TOWNSHIP MAPS OF WHITE EARTH.

It will be absolutely necessary for all those who are entitled to an additional allotment of land under the Steenerson act, to secure township maps of this reservation, and they should call at the American Land Company's office, in the TOMAHAWK office building, and leave their orders. These maps cannot be obtained elsewhere except at the office of the Indian agent who cannot allow them, under a strict rule of the interior department, to be copied or given out. The map which will be sold from the American Land Company's office will show all the unallotted tracts on this reservation. The price of the maps will be very reasonable, but in order to secure them in time orders must be given immediately.
