"Graustark" at the DeGraw

On Friday, Oct. 28, at the DeGraw Theatre, Baker & Castle will present the dramatization of George Barr McCutcheon's fiction, "Graustark," which was so successfully and delightfully presented the past two seasons.

The story of "Graustark" is of an American, Grenfall Lorry, who falls madly in love with a princess in America, who is traveling incognito. Chillicothe 11; Laclede 6

The football game last Saturday was one of the best and most interesting ever seen in Laclede. The Laclede team was in poor shape to play, but put up a good game, and the Chillicothe team is the best the local boys have met this season. Matsell went into the game with a bad knee and Capt. Jones had an injured hip, the result of the Shelbina game, but they, as well as the other players, put up a good game.

Chillicothe kicked off and Laclede rushed the ball to Chillicothe territory, all the backs making gains. Chillicothe got the ball on an attempted forward pass and punted to midfield. Another forward pass and a couple of line bucks gained 35 yards for Laclede. Chillicothe blocked a forward pass and punted from her 6-yard line. Chillicothe got the ball again on a forward pass and punted to the 45-yard line. Rowland grabbed the ball and, with perfect interference, shot through for a touchdown, and Jones kicked goal.

Laclede kicked off and Chillicothe rushed the ball to Laclede's 28-yard line, where the quarter ended. Laclede held them for downs on the 12-yard line and carried the ball back 25 yards, where they were forced to punt. A forward pass netted Chillicothe 20 yards and a series of line smashes put Jones of Chillicothe over for a touchdown. No goal.

Laclede kicked off and after an exchange of punts the half ended with the ball in Laclede's possession on Chillicothe's 25-yard line.

Laclede kicked off again. Both sides tried the forward pass frequently, seldom gaining, but Chillicothe gradually worked the ball to Laclede's 20-yard line and Atwell went through tackle for a touchdown. Jones kicked goal.

Chillicothe kicked off 50 yards to Jones, who returned 30, and quarter ends; Laclede's ball on her own 45-yard line.

Laclede played ball during the last ten minutes of the game. Six times they rushed the ball to within striking distance of Chillicothe's goal, only to be held for downs or lose the ball on an attempted forward pass. Chillicothe immediately punted out of danger each time. With three minutes to play Laclede made a last effort, gaining 30 yards on a forward pass and 25 more in three scrimmages and the ball was in Laclede's possession on Chillicothe's 1 1/2 yard line when the final whistle blew. Chillicothe 11; Laclede 6.

Both teams used the forward pass freely and both gained much ground by its use. Jones was the only Chillicothe player who could gain consistently through Laclede's line, while Jones, Matsell, Rowland and Kerr all carried the ball well for Laclede. Laclede's ends, though very light, do excellent work, and the line held well except for one weak place. It was a good game and a clean game and Chillicothe was lucky in winning it. At the rate Laclede was going when the game ended another scrimmage would have tied the score, but the time was up too soon.

Death of George M. Cassidy

George M. Cassidy, an aged and highly respected citizen, died at his home in Laclede last Sunday morning at the age of 75 years, 6 months and 17 days. He had been an invalid for a number of years and at time suffered greatly, but was always cheerful and uncomplaining. He was a good citizen and a noble man and will be greatly missed in the community.

George McLain Cassidy was born in Blairsville, Indiana county, Pa., April 6, 1835; married Mary Elisabeth Lee October 20, 1855, at Vermont, Ills. To this union twelve children were born, of whom two have preceded him to the great beyond; Mary L. Cornell dying in New Orleans in 1905 and Sarah Bowers in Weleetka, Okla., in 1906. The other children who, with the mother, survive him are Mrs. Ella Higgins, Bradyville, Iowa; S. E. Cassidy, Tulsa, Okla.; Mrs. Martha Jackson, Altai, Neb.; Mrs. Minnie Cameron, Hamilton, Mont.; Mrs. Clara Shoup, Meadville, Mo.; Mrs. Rosa Genrich, Mexico, Mo.; R. T. Cassidy, Brookfield, Mo.; G. L. Cassidy, Burlington, Iowa.; Mrs. Hattie Bissett, Laclede; Mrs. Gertrude Childress, Linneus, all of whom were here for the funeral. He also leaves 39 grandchildren and 19 great-grandchildren, two sisters, Mrs. Martha Wolf of Altoona, Penn., and Mrs. Sadie Humphrey of Bellwood, Pa., and one brother, R. A. Cassidy of Canton, Ohio.

He was converted and united with the Methodist church in 1860 and in 1867 united with the Christian church in Illinois, of which he was faithful member up to his death. By trade he was a shoemaker but in later years was a farmer and for the past eighteen years had been an invalid. He bore all his sufferings with christian fortitude and realizing that his end was near his last words were: "I'm not afraid to die; I'm so glad, so glad to go."

Funeral services were held at the M. E. Church yesterday afternoon at 2 o'clock, conducted by Rev. Killion of the Christian church. The bereaved family have the sympathy of all.
