## State Appropriations

The junketing committee of the senate and house has concluded its work with the following recommendation for appropriations to aid the state institutions:

State university, \$623,500; Rolla school of mines and metallurgy, \$80,000; Warrensburg normal, \$180,000; Kirksville normal, \$115,000; Cape Girardeau normal, \$146,000; Springfield normal, \$302,000; Maryville normal, \$302,000; St. Louis school for blind, \$101,700; deaf and dumb school, Fulton \$231,500; Confederate home Higginsville, \$92,900; federal soldiers' home St. James \$50,750; Fulton insane asylum \$78,475; insane asylum, St. Joseph, \$58,700; insane asylum Nevada, \$86,100; insane asylum Farmington, \$81,521; feeble-minded colony Marshall \$157,000; reform school for boys, Boonville, \$93,000; industrial home for girls Chillicothe, \$179,500 state sanitarium for tuberculosis, Mount Vernon, \$115,000; experimental fruit station, Mountain Grove \$40,700; state fair Sedalia, \$38,000; fish hatcheries St. Louis and St. Joseph \$15,000; geological survey of the state \$30,000.
