# CALLS COURTESY BANK'S BIGGEST BUSINESS ASSET

D'Nean Stafford Says It Outstrips Marble Walls in Convention Talk.

PLAY-UP HUMAN SIDE OF BANKING IS APPEAL

More Than 100 Attend Group Meeting at Elks Club Yesterday.

High capital stocks, big surpluses, imposing marble-faced buildings and all the systematic accounting of a bank are surpassed at a stroke as business getters by common honest courtesy. D'Nean Stafford, president of the First National Bank of the Cape, yesterday afternoon told the members of the Sixth Group of the Missouri Bankers' Association who were in session at the Elks Club.

More than 100 members of the group who control the work of most of the money in Southeast Missouri attended the convention and a banquet last night.

"Every banker knows the power of compound interest, and yet how few have reckoned the power of honest courtesy," declared Mr. Stafford. "Its power to produce is beyond the imagination of the conservative person, and even the enthusiastic believer in it often underestimates its great value.

"Courtesy should manifest itself in all the activities of the bank. Of course, we are grateful for deposits, but we should make our depositor feel our appreciation.

"The courtesy I want to talk about is not the grace of the salutation or the bowing or bending which distinguishes a man in high society; it is not that superficial shilly shally grin we sometimes get on our faces; it is not that which is false and insincere.

"Rather, the courtesy I want to talk about is that genuine heartfelt politeness combined with human kindness which gets its inspiration from the depths of a soul full of consideration and sympathy for our fellowmen and their welfare; it is that which leads us l to do things for people simply for the sake of being of service; it is that! which really and seriously makes us want to serve. It is written, 'He who would be greatest must be servant of all," therefore, if we take our work thus seriously, if we live toward our customers and the community a life of honest, conscientious service, we will not have to worry about results, our business will take care of itself.

"I am aware that an elegant building with elaborate furnishings appeals to some people; to others a large paidup capital and ample surplus; to others the prominence of men on the directorate and as active officers; to others what is commonly called efficient service; and to still another class, direct and indirect advertising. While each of these has much merit and is very essential to a bank"s welfare, still, persons thus appealed to will be as a rule easily led off to some other institution excelling in the same thing. Thus we have a large class shifting from one bank to another, and many of them do so without any excuse for making such a change.

"I believe if we will approach this roving class from the heart side, making them feel that we have a genuine interest in their success, they will cease to shift about and will become steady, producing customers.

"Take the banks of today and which side predominates? Unquestionably,

#### Proposed Admendment to the Constitution of Missouri

First Constitutional Admend-

Giving the General Assembly optional power to make provisions for the granting of pensions to the deserving

Joint and concurrent resolution submitting to the qualified voters of the State of Missouri, an amendment to the Constitution thereof, concerning pensions to the deserving blind.

Be it resolved by the Senate, the House of Representatives concurring therein;

That at the general election to be held on Tuesday, following the first Monday in November, 1916, there shall be submitted to the qualified voters of Missouri, for adoption or rejection, the following constitutional amendment to-wit:

That section 47 of article IV of the Constitution be amended by adding thereto the following words: "Provided further, that nothing in this Constitution contained shall be construed as prohibiting the general assembly from granting, or authorizing the granting of pensions to the deserving blind, as may be provided and regulated by law."

Second Constitutional Amendment. To empower the Legislature of Mis souri to create, by special law, a State Land Bank with power to loan mone; secured by deed of trust on agricul tural lands and to issue bonds, and an thorizing the appropriation of One Million Dollars (\$1,000,000,000) out of the State Treasury for that purpose and to exempt the capital and bond of said bank from taxation, and validating any legislation heretofore enacted for such purposes.

Missouri State Land Bank Amend ment to the Constitution.

Proposed by legal voters by Initia tive Petitions under the Initiative and Referendum Provisions of the Const tution, empowering the General A sembly to enact a special law creating a corporation to be known as the Mis souri State Land Bank, with powe to mobolize and liquidize farm credits to appropriate state moneys as a loa in aid thereof, and exempting from state, county and municipal taxes a of the assets of said bank, also deben ture bonds issued by it, and providin for the validating of any law enacte by the General Assembly in accord ance herewith.

Be it enacted by the people of the State of Missouri that the Constitution be so amended as to provide as fol-

lows: Section 1. The General Assembly hereby empowered to enact a speci law to create a corporation to known as the Missouri State Lan Bank, with power to make loans o notes secured by deeds of trust mortgages upon agricultural land and to issue debenture bonds agains the same with all suitable and inc dental powers. And to enact other special laws at the same session or other sessions of the General Assem bly to amend and improve the said ac or to supply omissions or correct e ors or defects therein.

Section 2. The General Assembly in hereby authorized and empowered to enact a law or laws appropriating a solution out of the moneys of the State Treasury, the sum of One Million Dollars as a working capital for said control of the state o

poration.

Section 3. The General Assembly is hereby authorized and empowered to enact a law or laws exempting from State, County and Municipal taxes the assets of said Missouri State Land Bank and all debenture bonds issued by it.

Section 4. Any law heretofore enacted by the General Assembly in accordance with the provisions of Sections 1. 2 and 3 hereof shall be deemed valid from and after the adoption hereof.
