

The Percheron Stallion Mike is 7 years old, 16 1-2 hands high, sired by Cheri No. 37762. Mike has the best style and action; he is wide out, with good ends, springy ribs and heavy, clean, flat bone and big foot—just the kind to breed to so as to raise large roomy mares to breed mules from.

He will be permitted to serve a limited number of mares up to June the 1st, at \$15 to insure a live colt, after which time he will go in training.



Money due when the fact is ascertained or when the mare is traded or sold, and those having mares served will be considered as making such agreement. The colt will be held as security until fee is paid. Care taken to prevent accidents, but I will not be responsible should any occur.
