To the members of the Bollinger County Farmers' Mutual Aid Society of Bollinger County, Missouri:

Notice is here by given that the regular annual meeting of said Society will be held at the court house in the town of Marble Hill, Missouri, on Saturday, October 28, 1922, at 1 o'clock P.
