EMPLOYEE GETS FRESH LIGHT ON DEVELOPMENTS

Commends Noble Purposes of Mr. Holmes.

Flat River, Mo., Oct. 5, 1915.
 Mr. Editor:—A copy of Mr. Holmes' Circular to the stockholders of the St. Joseph Lead Co. has just reached me, and I think it is my duty as a laboring man, to say something in behalf of this noble man, who has the laboring man's interest at heart. The position that he took at the Trustees' meeting on October 9, 1914, at St. Louis, speaks for itself:

Curtailment of Production.

On Oct. 9, 1914, a special meeting of the Trustees was held in St. Louis for the purpose of considering the reducing of the output of the mines on account of the low price of lead then prevailing. After discussion a resolution was offered reducing the working time of the men from six days to five days per week. I considered that it was not fair to cast the entire burden on the working men in view of the fact that the cost of living was steadily increasing and stated that I would be willing to vote for the resolution only on condition that the salaries of all the employees of the Co., including the officers, be reduced in proportion to the cut in time for the men. The other directors objected to this and I therefore did not vote for the resolution. The minutes of the meeting when sent to me for approval did not state the reason why I did not vote in favor of the resolution and at the next meeting, held in Bonne Terre on November 10th, although I requested that my reason be inserted in the minutes, all the other directors refused to grant my request and voted to let the minutes stand as they were originally drafted.

Mr. Holmes, as I understand it, was the only man, holding great interest in the Doe Run Lead Co., who seemed to appreciate the great service rendered by Mr. F. P. Graves, which made the Doe Run Lead Co. what it is today. Anyone familiar with conditions knows that it was Mr. Graves' foresight and hard work that made this one of the greatest mining companies in the world; so much so that the president, Mr. Crane, can draw a salary of \$25,000. a year and ride in a special car when visiting this district, and other minor officials can draw from \$5,000. to \$20,000. per year. In this connection it is interesting to note the treatment assigned to that earnest friend of the laborer, Mr. F. P. Graves.

No doubt that Mr. Holmes' love and loyalty for the laboring man and Mr. Graves, is responsible for him being put off of the Board of Directors of the St. Joseph Lead Co.; but I hope that it will be only a short while till Mr. Holmes will be able to accomplish his purpose to bring about better conditions for us laboring men; as he seems to appreciate that we laboring men love our wives and our children as much so as these officials drawing those handsome salaries.
