THE A. D. SPRATT WILL CASE.

Lydia F. Nichols' Suit Awakens Keen Interest in the Western Part of Andrain County.

STURBOUR, Mo., Dec. 28.—The A. D. Spratt will case is agitating this section of the country as few legal cases ever have. Intense interest was recently aroused by the action of Lydia F. Nichols, formerly Mrs. Herndon, who filed suit against the Spratt estate for \$7,000. The action is based on an alleged marriage contract, dated in September, 1888.

The following is a copy of the article submitted in evidence: This agreement made the tenth day of September, 1888, between A. D. Spratt, of the county of Andrain, and Lydia F. Herndon, of the county of Andrain, Winesmith, said parties, in consideration of the marriage about to be entered into between them, do hereby agree that after and during such marriage each of the parties hereto shall have, hold and use as his or her sole and separate property and estate, free from the control or use of the other. Said parties further agree, when called on by the other, to join in the execution of any deed or any instrument or writing of the other the A. D. Spratt, being myself, should I arrive the party of the second part, to release the estate of the second party from all claims I would have as husband if it were not for the execution of this contract, and I, Lydia F. Herndon, do bind myself, should I survive the party of the first part, to release the estate of the first party from all claims I would have as wife of the first party, except that I shall have a one-half interest in the entire estate of the first party, that being a share equal to that of his child Leslie, now living, or if there should after this marriage be other children borned to him they shall share equal with my daughter, I, A. D. Spratt, do further bind myself, as I am not just ready for this marriage to take place, on account of my daughter, who opposes our marriage, but I do agree for this marriage contract to stand good, and on the 25th day of December, 1888, I, A. D. Spratt, and Lydia F. Herndon, will be married if we are living. I, A. D. Spratt, in consideration that the party of the second part does bind herself to wait on the first party until the 25th day of December, 1888, with the consideration that if I do not fulfill the contract at that day, Lydia F. Herndon shall have the sum of two thousand dollars (\$2,000) at any time thereafter she may demand it, as a forfeit to her; and if there are any expenses attached to this contract, I, A. D. Spratt, agree to pay all expenses that may occur. LYDIA F. HERNDON.

Prof. and Mrs. French Strother Soared Out of the Indian Territory by Smallpox—Left their Clothing.

Correspondence of the Ledger. MORNINGTON, TENN., Dec. 26.—We left South McAlester, I. T., on Dec. 21 and arrived here on the 26th, being two days and nights on the road. We expected to reach Union Hall, Va., in a few days and hope to find a copy of your paper there and to receive the weekly regularly.

By special invitation we dined to-day at the fine Morrison hotel, the Virginia House, truly worthy of the name. It is kept by Virginians. Never did I eat such a Christmas dinner.

We left Mexico on Dec. 5, reached McAlester the 6th and left there for Virginia the 21st. There was too much smallpox there to suit us. We sent out a two weeks' washing, but left the clothes, as we heard they had been taken to a house where it was said there was a case of smallpox. Nobody at South McAlester seems to fear this plague, but strangers dread it.

While I was there the streets were crowded with people from all over the world. It is a live place with a great future. There are great inexhaustible beds of fine coal all over the country. Thousands and thousands of car loads of coal are being mined year after year, and small towns are springing up all over the country.

The last Sunday I was there the schools and churches were closed on account of smallpox. Some, however, wear it is not the smallpox, but the Cuban itch. Nobody seems to be dying from the disease, and it is almost entirely confined to the negroes.

What frightened my wife was, that the faculty physician telephoned my daughter-in-law not to let her cook return for her mother had the smallpox, so we were afraid to bring with us our washing of two weeks, which had been taken by the cook to her mother's house.
