Minneapolis, Aug. 24.—

It was rumored that the nature of the report is such that the executors will have to face an effort of the state to collect an inheritance tax that will amount to \$900,000.

Bank Promotor Taken by Sheriff

F. E. Anderson Wanted at Fort Benton for Selling Fraudulent Stocks Arrested at Glendive. Sheriff Geo. Twible of Dawson county has succeeded in capturing another man wanted in various places for conducting a fraud and fleecing people out of their money. The man taken into custody this time is one F. E. Anderson of Billings, vice president of the Plymouth Securities company of that city. He is wanted at Fort Benton for selling fraudulent stocks and by the state authorities for conducting the business of the firm after its license had been revoked. He was arrested at Fort Benton some time ago and released on bond, but he disregarded the bond and went on conducting his questionable business. Sheriff I. M. Rogers of Fort Benton arrived Tuesday morning and left the same morning on the valley train, taking his prisoner back to Fort Benton to stand trial. Anderson's latest venture was hoodwinking people all along the Northern Pacific railroad into investing money in a bank to be started at Stivek, Mont., and another at Carlyle, Mont. He had already swindled a number of people out of thousands of dollars and would in all probability have made a large haul had he not been apprehended and arrested by Sheriff Twible. His game was to pose as a representative of some large capitalistic firm interested in the establishment of banks at various points where banks might be a paying proposition. He conducted his campaign in an automobile which made his apprehension a comparatively easy matter.—Glendive Monitor.
