### Iron Dealers Are Under Arrest at Fargo

#### ALLEGED FARGO IRON & METAL CO. KNOWINGLY BOUGHT STOLEN PROPERTY.

Fargo, N. D., June 16.—Sam Paper and A. Yoffey, of the Fargo Iron and Metal Company were arrested Saturday on warrants issued by the Northern Pacific Railroad and the Rumley Products Co. charging the Fargo Iron and Metal Co., with knowingly buying stolen property. They were taken before Judge Hanson in the county court and entered pleas of not guilty and were released on bonds.

The arrest of the members of this firm is the outgrowth of the brass stealing which has been going on in this city for some time. Some time ago the Rumley Company became aware of the fact that they were losing brasses and the police were notified and a sharp watch was kept of all places where such brass might be disposed of.

Over a week ago several boys were caught in the police drag net and their statements in a way led the police to believe that there were others who might be implicated in the matter besides the boys.

A search warrant was issued for the investigation of a car which was to be shipped to an eastern firm by the Fargo Iron and Metal Company. The car contained a certain amount of rags; and also brass which was identified as belonging to the Northern Pacific Railroad and the Rumley Company. The special agents in the employ of the railroad claim to have an interesting chain of evidence in the matter.

### \$500.00 Reward For Information

Bowbells, June 13.—A reward of \$500 has been offered by Mrs. Ojust Henricks of Plaza, for information as to the whereabouts of her husband, who has been missing from his home since April 9, when he left for one of the neighbor's farms to purchase some cattle. An account of Henrick's disappearance appeared in many papers a few weeks ago but notwithstanding widespread publicity no trace whatever has been found of him.

A peculiar feature of the case is that Henricks had little or no money with him when he left home, carrying his check book and some small change. Since his disappearance, however, he has not drawn a cent on his account in one of the banks in this city, so if he is still alive he must have employment at some point.

Henricks is 41 years of age, is about 5 feet 8 inches in height, has brown eyes, and two front teeth are missing. He was smooth shaven. The missing man was engaged in the dairy business.

### Fields in Ward Co. Badly in Need of Rain

Minot, June 14.—Rain is badly needed by many of the farmers in the southeastern part of Ward county according to reports received in this city today.

Many of the farmers in that section were late in seeding, and as a result have had practically no rain since the seed was put in the ground.

The warm weather has helped the crop to some extent but it is felt that it is absolutely necessary that rain should fall within a few days if the crop is to be as good as has been expected.

A good fall of rain at present seems to be all that is necessary to make probably a banner crop.
