NEW CHURCH OPENS MONDAY



New Christian Science Church at Willmar.

The edifice for the First Church of Christ Scientist is now completed, and it will be opened for worship with special services on Monday, Nov. 21, by Mr. Herman S. Hering, of the board of lecturers of the Mother Church in Boston. Mr. Hering was formerly a member of the faculty at the John Hopkins university.

Like all Christian Science churches the Willmar church was founded on healing. It had a rather unusual start in that it was begun entirely by men. Nine men, who, one after another had found help in Christian Science, met together every Sunday to read the lessons for nearly three years before a single woman became interested.

The church was organized in the spring of 1903 with 14 charter members. Among these were C. W. Odell, cashier, First National bank; O. P. Nelson, retired farmer, and O. E. Ruble, a prominent real estate owner. The first reader at the present time is Mr. O. A. Sand-

ven, with Mrs. A. C. Skoog as second reader. The board of directors is composed of A. C. Skoog, president; C. W. Odell, clerk; O. P. Nelson, treasurer, and Mrs. C. W. Odell.

The new church is a beautiful structure. It is the result of much earnest work and generous giving on the part of the members. It is situated on one of the best corner lots in the city, on the south side of the courthouse square. The interior finish is in mission oak, the walls being tinted in dark gold, and floors being laid with crimson carpets. The reading room is in the church, finished and furnished like the church. There is a full basement under the church, and this will eventually be used for Sunday school room. The total cost of the building and lot is \$8,000. The dedication will take place as soon as the property is free from any encumbrance, which will most likely be some time next spring or summer.

LOCAL SOCIETIES OF EQUITY

An attempt is being made to organize a number of local branches of the American Society of Equity in Kandiyohi county. Mr. A. E. Gratreals, an organizer from Wisconsin, has held meetings in a number of the school houses in the southern part of the county for the purpose of explaining the objects and purposes of this society, and informs the Tribune that he is soon ready to begin the organization of locals throughout the districts he has visited.

Since the days of the Farmers Alliance there has been no attempt to organize the farmers that has met with the success that has so far come to the Society of Equity. In some states it has won a wonderful standing, with thousands of members. When five or more local societies have been formed in a county, a county society may be formed. These in turn are represented in state or district societies.

It may interest the readers of the Tribune to know something more about the aims and purposes of the Society of Equity, and the Tribune knows of no more concise way to do this than to publish the objects of the Society as published in its constitution. They are:

1. The first and great object of this society is to obtain profitable prices for all products of the farm, garden and orchard.
2. To have built and maintained granaries, elevators, ware houses and cold-storage houses on the farms, in the principal market cities and in localities where necessary, so that farm produce may be held and controlled for an advantageous price, instead of passing into the hands of middlemen or trusts.
3. To obtain equitable rates of transportation.
4. To secure legislation in the interest of agriculture.
5. To open new markets and enlarge old ones.
6. To secure new seeds, grain, fruit, vegetables, etc., from home and from foreign countries, and distribute them with a view of improving present crops and giving a greater diversity.
7. To report crops in this and foreign countries, so that farmers may operate intelligently in planting and marketing.
8. To establish institutions of earning, so that farmers and their

13. To settle disputes without recourse to law.

14. To promote farmers' societies in foreign countries.

CANNOT EVADE THE ISSUE.


