

Sealed bids will be received by the City Council of the City of Willmar, Minnesota, up to 8 o'clock in the afternoon on March 27, 1916, for all labor and material required for the construction of approximately four thousand (4000) feet of four inch standard cast iron water mains in the City of Willmar, and for furnishing and installing three (3) standard gate valves; four (4) Watertown fire hydrants, or equal, and two (2) blow out valves, all to be in strict accordance with plans and specifications now on file with the Water and Light Commission, and with the City Clerk of said City.

Bids to state price per foot for additions or deductions from four thousand (4000) feet of water mains, as above stated, and also price of extra gate valves, fire hydrants or blow-out valves that may be wanted of same quality as called for in specifications. All bids must be submitted on bidding blanks furnished by the City of Willmar, and must be accompanied by a certified check, payable to the Treasurer of said City, for at least ten percent of amount of the bid, as a guaranty that the bidder will enter into a contract and perform the work in case the contract is awarded to him.

Bids to be sealed, addressed to the City Council of said City, and marked "Bid on Water Main Extension." The Council reserves the right to reject any or all bids.
