DUMPY TRADE IN CATTLE AND HOGS

Some Kinds of Cattle at Year's Low Point. Fair Tone in Sheep Market

(By U. S. Bureau of Markets and Minnesota Dept. of Agriculture)

Monday's Opening, South St. Paul, Minn., April 11, 1921: Cattle 1700, market slow, steady to 25c lower, top steers \$8. Calves 200, market steady, packer top \$6.50. Hogs 5300, market 25 to 35c lower, range \$7 to \$9.40, bulk \$8 to \$8.75. Sheep 400, market fully steady, best clipped lambs \$8.35. Shorn ewes \$5.50.

Live stock trade is lumpy. Although there is a fair undertone in the sheep market, trade in both cattle and hogs is dull with price tendency downward, hogs and some classes of cattle at present selling at the lowest levels for the year to date.

Cattle are coming to leading markets in fairly liberal numbers for this season of the year, and with continued light demand from the country for stockers and feeders, and consumption of dressed beef low on account of the greatest amount of unemployment at any time during the present industrial depression, the market is on the down grade, opening the week at steady to 25c lower prices, after a break of 50 to 75c last week. A few good to choice fed steers brought \$8.00 Monday, with load lots of medium to good steers at \$7.65 and \$7.75, and bulk of common and medium grades from \$6.50 to \$7.50. Choice heifers are quotable up to \$7.50 and \$7.75, with bulk of the butcher cows and heifers selling from \$4.50 to \$6.25. Canners, cutters, bologna bulls and veals are moving at the year's lowest levels, canners and cutters selling from \$1.50 to \$3.50, bulk of bologna bulls \$3.50 to \$3.75, and top veals \$6.50. Stocker and feeder trade is slow and draggy, with prices working lower.

Packers' droves of hogs were put up Monday at a cost of slightly under \$8.50, bulk selling from \$8 to \$8.75, or 25 to 75c lower than a week ago. Coarse heavy packers landed at \$7 and choice pigs \$11 and \$11.25, showing the market extremes at the present time. Sheep sold fully steady, choice 75 lb. clipped lambs bringing \$8.35, choice light clipped yearling wethers \$8, a deck of choice shorn wethers averaging 113 pounds \$6, with a few clipped ewes at \$5.50.
