ANNUAL CATTLE CLEANUP AT HEIGHT

Largest Cattle Run of Year to Date Estimated at 15,500 Arrived Monday; Market 25c Off

By U. S. Bureau of Markets & Crops Estimates and Minn. Dept. of Agr. Monday's Closing. Cattle 15,500. Market closing mostly weak to 25c lower. Few fed heaves \$7.25 to \$9.50, best grass heaves \$6.25 to \$9.50, market closing mostly 25c lower, best lights \$7.50. Hogs 14,500. Market 10c to 25c lower, bulk \$6.25 to \$6.65, top \$6.75; bulk good pigs \$7.50 to \$7.75. Sheep 18,000. About half killers. Good fat lambs \$8 to \$8.25, bulk good ewes \$3 to \$3.25, few \$3.50. South St. Paul, Nov. 14.—With snow and colder weather general throughout territory tributary to the local market the annual fall cleanup of cattle on farms is at its height, the largest run of the year to date estimated at 15,500 arriving for Monday's trade. The supply of cattle proved somewhat in excess of the demand and the market was for the most part around 25c lower, although good and choice stockers and feeders selling from \$5.25 to \$6 were about steady. Receipts included one load of fed Angus yearlings averaging around 800 pounds and these had bids up to \$9.50, but these were shipped to Chicago. Some short-horn yearlings weighing around 1,100 pounds brought \$7.50. Best grass heaves here brought \$6, packers paying the price for some 1,250-pound Montana. Bulk of the grass heaves sold from \$4.50 to \$5.50. Butcher cows and heifers went largely from \$3 to \$4.50, with a few of the best young cows and heifers of handy and light weights up to \$5.50. Practically no fed steers were included. Canners and cutters were weak to 25c lower, selling at \$2 to \$2.75. Bologna bulls brought \$2.50 to \$3 for the most part, a few \$3.25. Practical packers top for best light vealers was \$7.50, a few extra choice ones up to \$8. Bulk of stockers and feeders sold from \$4 to \$5, commonest kinds from \$3.25 to \$3.50. Hogs opened 10c to 25c lower, range \$4.75 to \$6.75, bulk \$6.25 to \$6.65. About 5,000 pigs here, bulk good kinds \$7.50 to \$7.75. Bulk good fat lambs \$8 to \$8.25, good fat ewes \$3 to \$3.50, feeding lambs \$5.75 to \$7.25.
