P. G. Wilson of Stately has been granted a pension of \$12 per month.

The Springfield Advance says that Christian Ahlness is a candidate for judge of probate.

Fred Van Patten, who was lately married to a Courtland lady, is now building a farm house on his place in Stately.

In the Springfield district W. H. Rowe has announced himself as an independent candidate for county commissioner.

Miss Emma Ciziskliba, who spent several weeks here two years ago, died at her home in Amherst, Wis., last week of typhoid fever.

Mr. Goessel, a representative of the Evening Wisconsin of Milwaukee, is spending a few days here with his mother, Mrs. Baptiste Karl.

Mrs. A. A. Ames, the wife of the Minneapolis ex-mayor and Democratic candidate for governor, is dead. The doctor abandoned her some time ago. A lawsuit was brought to see who should have the furniture, and under the law the doctor won. She then went to live with her daughter. About ten days ago the doctor was arrested for nonsupport. The case was continued and of course now will come to trial. Her death can be laid to the recent troubles and it shows how false was the claim that Dr. Ames was ever a "friend to the people." Before her death, she besought her daughter and son-in-law that her recreant husband should never see her face in death. She was buried by them, but the husband caused an unseemly scene by attempting to have the body removed to another cemetery, which was prevented by the authorities.

The amount necessary to continue the operations of the Farmers' Warehouse and Elevator Company has been now practically all raised. Over 100 shares have been taken and this is a sufficient amount to pay off the indebtedness and to commence operations for the fall grain trade. At the last meeting held Saturday, two committees, one to work for subscriptions south of the Cottonwood river and one to push the matter on the north side, were appointed. They were Silas Blackman, Conrad Blackman and J. F. Wendt. The former two have been at work in Stately, Bashaw, Mulligan, Leavenworth, and in the north tier of towns in Cottonwood county which are in a measure tributary to Springfield, and we hear they are meeting with the most gratifying results. Mr. Wendt, in company with D. J. Sheffield, ex-president of the company, has been putting in good solid efforts in Burnstown, and North Star and also in the Redwood county towns of Brookville and Sundown, and to some extent in other territory adjacent. They report that they find little trouble to enlist the farmers in the project.—Springfield Advance.

The Turnverein has elected E. G. Pahl, F. Friedmann and F. Sittel as a Bar Committee to fill a vacancy.

At a meeting of the State Central Committee in St. Paul last Saturday, Jamison of Minneapolis was made chairman and Tams Bixby secretary.

The Gebser building, south of Wicherski's, is being repaired this week and in a few days will be occupied by the Brereton Bros. of St. Peter.

Andreas Ure of Bird Island was fined \$5 and costs last week for drunkenness by Justice Nix. Not being able to pay the fine he was lodged in jail.

A paper will be issued at the Swan Lake Camp. Its politics will be independent in that its editors will say just what they mean and whatever they please. At any rate so reads the motto.

The Mable Purchasing Co. of Chicago brought suit against Jos. Fesemeyer last week for broken contract. The case was given a jury trial before Jacob Nix on Saturday and a verdict was returned showing no cause of action.

A Democratic club of seventy-four members has been organized in Springfield. J. C. Rothenburg is president, Chas. Gamble vice-president, Wendell Vahlle secretary, John Schmelz treasurer and John B. Schmid marshal.

A curious phenomenon is reported from Marshall. In one of last week's showers two snakes several feet long came down with the rain. They were of a variety found in the southern climates, but not in this locality, a local naturalist states.

In the Democratic State Convention, Brown county did not fail of recognition. T. E. Bowen, formerly of Sleepy Eye, was one of the committee at large on organization. Fred Gley, formerly of New Ulm went onto the same, committee and E. P. Bertrand secured a place on the committee on platform.

A moderately clean bear and a couple of dirty men gave an exhibition of child's play on the streets last Thursday. The only amusing thing about the performance was the fact that such exceptionally lazy men could be so foolish as to make a public display of their lack of energy, and that the public could be foolish enough to patronize their want of thrift.

Col. Baasen went to Smith's Mills yesterday to try a case in which Jake Leonard, a conductor on the Northwestern road, between Waseca and Tracy, is sued by a tramp. The particulars of the case are about as follows: The other night as Leonard's train left Tracy there were twenty-one tramps on board. They were first discovered at Waseca and all but six were put off. These remained on the train without being seen until they had passed Smith's Mills, and upon reaching Eagle Lake they were told to get off. They refused to do so and the crew found it necessary to use force. The first one who got off picked up a stick of wood, but was prevented from doing any harm by conductor Leonard. The second grabbed at a stone, but was knocked down before he could reach it. The rest left in peace, and the injured tramp was left near the track alone. His face was bleeding somewhat and when discovered by some of the Eagle Lake people, who seem to have a grudge against Leonard, he was taken to a hospital and induced to commence suit. A change of venue to Smith's Mills was secured and there Col. Baasen expects to win the case for the train men.


