The annual picnic of the Nicollet County Creamery Association will be held June 15 this year and the school grounds of Lafayette village will be the scene of the day's festivities. The picnic will be held simultaneously with a meeting of the Nicollet County Farm Bureau and an effort will be made to secure Governor Burnquist as one of the speakers for the occasion.

Lieut. and Mrs. Max Sebald are visiting at the home of the latter's parents at Cobden, Lieut. Sebald having been given a leave of absence after several years of service in the Philippines. Lieut. Sebald served several years in the Third U. S. Infantry stationed at Fort Snelling and when the regiment was in the islands, applied for and received a commission in the constabulary department.

George R. Kirkpatrick, noted author and lecturer of New York City, will speak at the Liberal Union Hall at Hanska, Friday evening May 12th. The subject of his address is "Think or Surrender," and is a discourse on the present system of public school education, the speaker favoring several radical changes in the courses of instruction. Mr. Kirkpatrick is the author of "War—What For," recently published, and regarded as one of the most radical arguments against war ever published.

Work has been started on the foundation for the new cement tile works to be constructed by the recently organized Saffert-Guggisberg Cement Construction Co., on the M. & St. L. right-of-way on Third North street.
