There were three candidates for aldermanic honors in the first ward, Hands, Knudsen, the present incumbent, being opposed by Martin Casperson and Matt. Raymond, the latter entering the race as a "sticker" candidate, as he decided to make the race too late to have his name printed on the official ballot. There was no opposition to the regularly nominated candidates for recorder, treasurer, municipal and special judges and three aldermen. The candidates for these offices, in the order given, were A. J. Thomas, Ray Brust, John Cutting, J. L. Kiefer and J. A. Fialka, Geo. Martinka and F. E. Beech.

Nicollet county's population is decreasing according to the vital statistics report for the year 1919 received by County Clerk Wm. Malign from the State Board of Health. In this report the county was credited with 256 births and 327 deaths. The deaths of the state as a whole are included in the exceedingly high death rate in St. Peter which totals 267 deaths against only 49 births. **MEETING TO BOOST BIG INTERCHURCH MOVEMENT.**

Rev. Dr. J. N. Strain of Marshall to Preside At Gatherings Held Here Today.

Three conferences will be held today, Wednesday, in the interest of the Interchurch World Movement, at the local Methodist Episcopal church. The purpose of this movement is to bring about a more practicable co-operation between the various denominations. The three sessions will be presided over by Rev. Dr. John Newton, Strain of the First Presbyterian church at Marshall. A number of out-of-town speakers have been secured to deliver addresses on subjects relating to the movement. The first session will be held in the morning, another one in the afternoon and the third in the evening. The lecture in the evening will be with stereopticon slides to illustrate the unnecessary division of church forces in certain communities. The public is invited to attend the sessions. There will be no admission charge to any of them.

Dr. C. L. Baerwald was elected Davenport's (Iowa) first Socialist mayor last Saturday carrying 12 out of 18 precincts. His plurality over Henry Jehens, Republican, his nearest competitor, was 1,655. The Socialists carried all other city offices with the exception of treasurer. They also will control the next council, electing five out of eight aldermen.

Opposition to the regularly nominated ticket for the city election at Sleepy Eye, yesterday, developed last week, when H. H. Offermann decided to enter the mayoralty contest against Mayor C. C. Hansen, who has held this office during the past year. Dr. A. F. Strickler, who sought re-election as alderman-at-large, had opposition in the person of J. D. Youngman. There were three candidates for aldermanic honors in the first ward, Hands, Knudsen, the present incumbent, being opposed by Martin Casperson and Matt. Raymond, the latter entering the race as a "sticker" candidate, as he decided to make the race too late to have his name printed on the official ballot. There was no opposition to the regularly nominated candidates for recorder, treasurer, municipal and special judges and three aldermen. The candidates for these offices, in the order given, were A. J. Thomas, Ray Brust, John Cutting, J. L. Kiefer and J. A. Fialka, Geo. Martinka and F. E. Beech.

Nicollet county's population is decreasing according to the vital statistics report for the year 1919 received by County Clerk Wm. Malign from the State Board of Health. In this report the county was credited with 256 births and 327 deaths. The deaths of the state as a whole are included in the exceedingly high death rate in St. Peter which totals 267 deaths against only 49 births. The vital statistics for the rest of the county were as follows: Belgrade, births 15, deaths 6; Bernadotte, births 14, deaths 5; Brighton, births 6, deaths 4; Courland, births 15, deaths 1; Granby, births 16, deaths 1; Lafayette village, births 3, deaths 2; Lake Prairie, births 22, deaths 8; New Sweden, births 8, deaths 2; Nicollet village, births 8, deaths 4
