Territorial Jottings.

Socorro demands a brass band.
The Socorro Miner trots out its new map by which the advantages of the town are clearly shown up.

The Indians at Isleta celebrated the harvest festival last Sunday and a large excursion went down from Albuquerque.

Rev. J. A. Menaud of Butler county, Pa., is trying to build a Presbyterian church in Albuquerque.
The Bernalillo News is the latest candidate to journalistic success in the Territory.

The Albuquerque Journal claims that L. P. Davis who was to have charge of the new paper at Georgetown, Grant county, has acted in a "contemptible" manner and that the Journal will have nothing to do with the paper as at first proposed, and has ordered Davis to give up the material furnished by that paper.

Albuquerque Journal: C. W. Lewis' ranch, situated about forty miles east from here, is one of the finest places in the country.

H. W. Elliot was just about to close a \$40,000 sale of mining property in the Black Range to George Daly of Lake Valley when the latter met his tragic death in the Indian campaign.

About a week ago a difficulty occurred between two men, Goodjohn and Wesley Whitney, members of the Texas & Pacific R. R. party, near Little Burros, nine miles southwest of Silver City, in which the latter was shot, and it is thought, mortally wounded. Goodjohn was arrested.

John W. Foster, superintendent of the Conroy mines, in the Mogollon Mountains, has discovered the main lead of the Silver Bar, 70 feet east of what has always supposed to have been the main lead, and on which \$5,000 of work has been done.

Another big gold strike has been made on the Great Western claim, near Silver Creek, in the Mogollon Mountains.

Edward E. Furman writes an appeal to the citizens of Grant County to rise up and kill off all Indian marauders. He has been endeavoring to organize a force to permanently take the field against the hostile Indians.

The Cedar Grove mining camp, situated thirty miles southeast of Cow Springs, was taken in by Indians. James Fay, one of the principal mine owners, was killed, and John Grodhouse wounded in the arm. Everything about the camp belonging to the miners was destroyed.

Everything is prosperous about the Steeple Rock district. The roads are bad at present, but it is proposed to build a good wagon road at a cost of \$1,000 from the district to Lordsburg, on the Southern Pacific, the nearest railroad point.

"Doc" J. W. Porter, of Silver City, has obtained the following returns from four assays of ore from his "Lulu" mine in the Bullard Mountain district near that place: Three hundred and eight ounces, 118 ozs., 88 ozs. and 251 ozs.

Silver City Chronicle: The entire party engaged in chopping wood for the post at Fort Cummings were taken in by the Indians. Desadario Heredia and Patronillo Chacon were killed at the camp, and Mannel and Juan Chacon, lads of twelve and fourteen years of age, are supposed to have been carried off prisoners, as their bodies could not be found.

Favorable reports come from the Eureka district in the southwestern part of the Territory. Work on the principal mines is being rushed and large quantities of high grade ore is being taken out. The Owl company is developing some rich leads, and has expended large sums of money at Eureka, and the mill and reduction works will be in operation some time this month.

Ben St. Cyr has been awarded the mail contract between Silver City and Georgetown—six trips per week. His contract is direct with the department, and commenced on the 1st of September.
