The following communication was handed us, by one of the substantial farmers in that town, it is in answer to a request of ours for a short sketch of each township in the county:

COMSTOCK. Town 153, range 46, recently organized under this name. It was first settled in the spring of 1878, by a few Germans, but Peter Reetz was the only one who made any improvements. In the spring of 1879, a few more claims were taken and some breaking done, but no crops were raised except a few potatoes. The spring of 1880, the remainder of the settlement was made, consisting of some twenty-five homestead and pre-emption, and twelve tree claims. Last year was the first crop that was raised, and was not a very large one, but we do not think it was any fault of the land or the season, but the late breaking, poor and late seeding. We hope to tell a different story next year. There was about 160 acres of wheat and 50 acres of oats last year. For the coming season there are 700 acres to be sown to wheat and oats, and most of the ground is in good condition for a crop. We understand that some flax will be sown this spring, but how much we have not heard.
