To the Public.

—The recent appointment of a Clerk of the District Court, for Marshall county, gives pre-emptors and homesteaders local facilities for securing homesteads and making final proofs. Hereafter, J. P. Nelson, the clerk of the District Court for this county, by authority vested in his office, can take applications for or final proofs in homestead and pre-emption claims, at his office in this place, excepting when the District Court is in session, when the presiding judge will in open court, take final proofs.

Aliens who wish to become citizens of the United States, as they must before taking government land, will go before the same official, take the oath of allegiance and receive naturalization papers. He alone can issue marriage license for this county.
