### HARVESTED BY HAIL.

A Terrible Storm Swept Through Northern Dakota Late on Yesterday Afternoon.

In Traill and Steele Counties Alone it is Thought the Loss Will Reach 2,000,000 Bushels.

Partial Abatement of the Small-Pox Scare at Mason City, Ia.

Failure to Pay a Debt Causes a Murder and Suicide at Butte.

Storm Swept. Special to the Globe.

MAVILL, Dak., July 23.—The most violent storm of the season reached our city and vicinity at 5 o'clock this afternoon. A very heavy rain was concluded by a worse hail storm. For at least ten miles south, and as many west, the loss may be estimated as total. The frequent reports from this country up to this hour, 10 p. m., continue to be more and more discouraging. So far the Goose river valley wheat had looked the best in North Dakota, but to-morrow's sun will shine upon the hail-mown fields of hundreds of sorrowing farmers. Good judges say the loss will surely reach from 1,000,000 to 2,000,000 bushels in Traill and Steele counties. Several bodily injuries are reported. Mr. Thorsen had both arms broken by a load of hay falling on him.

Wheat in Good Shape. Special to the Globe.

FARGO, Dak., July 23.—Light showers fell here to-night, doing much good. They are the first in three weeks, and are said to be much heavier south and east. It is reported that hail fell north, in Traill county, one section of the Grand Bonanza farm being cleaned out. Some farmers commenced harvesting wheat to-day in Foster county, near New Rockford, and dispatches stated that the wheat is turning out much better than anticipated. Some who a week ago counted on only five bushels now claim ten and fifteen.

The Crops. Special to the Globe.

LAKE BENTON, Minn., July 23.—The harvest here is in full blast. The wheat crop is fine. The straw is rather short, but the heads are well filled and free from smut or rust. The oat crop will be light. Barley and flax are good. Late sown flax will need more rain as it shows the effect of drought. The corn crop never looked so well.

Small-Pox at Mason City. Special to the Globe.

MASON CITY, Ia., July 23.—The small-pox scare in this city and county has somewhat abated. Yesterday the board of health decreed that all the residents of the city who have not yet been vaccinated, must be at once. The account of the contagion existing in Boland has been somewhat exaggerated. May 30 Christian Detrick, with his wife and four children, arrived from Germany and shortly after his wife was taken sick. Being a feeble woman it was thought that her sickness was due to fatigue caused by the long journey. A German minister and physician was called in and pronounced the disease small-pox and enjoined the greatest care lest the contagion should spread. Notwithstanding this the family visited and received visits from neighbors. Finally Mrs. F. Brown caught the disease and took to her bed. The township was notified at once and the trustees immediately notified the state board of health. The local board quarantined the district but was powerless to enforce its orders. The state board of health appointed a physician to look after the cases, and he has been engaged since diligently performing

his work. He reported to-day that there are only four cases of small-pox in Barton township. The German woman has recovered. Mrs. Brown and her daughter are getting better, but two boys in the Brown family are just coming down. Steps have been taken to arrest several persons for disobeying the orders of the board of health.

The Sengest. MILWAUKEE, July 23.—When to-night 2,500 male voices filled the vast Exposition hall with the wealth of melody contained in the prize cantata, "Columbus," an audience of 12,000 people listened and demonstrated their approval at its close by giving Director Catenhusen of the National sengerband a perfect ovation.

It was its perfect performance, its composer, Joseph Brambach of Berlin, having won a prize of \$1,000 in competition with five of the most eminent composers of both worlds, for the best original composition written for this occasion. John Plankinton, the millionaire, is the donor of the prize. President Mendel cabled the eminent composer congratulations to-night on the unqualified success of his composition. To-morrow many of the singers will depart for home. To-day they spent in picnics at suburban parks and in getting up grotesque processions. To-night numerous torchlight processions and serenades took place. The Eichen Kraus society of New York gave a reception, commencing at midnight. Prominent guests were present from all parts of the country. All the songs and declamations were composed for the occasion. The affair was conducted on an elaborate scale, and did not conclude until a early hour in the morning. St. Louis or Indianapolis will be the next place of meeting, probably the former.

FORT KEOGH, Mont., July 23.—Edward R. Brown, who shot and killed last week John Toohy, late postmaster at Birney, Mont., was cleared by the coroner's jury of any criminal intent. Yesterday Toohy's relatives, who arrived from Chicago, had Brown arrested. He was released on \$10,000 bail to appear before the grand jury at the next term.

Murder and Suicide. BUTTE, Mont., July 23.—Early this morning J. W. Moore, late of Nevada, shot Joseph Henderson, a clothing merchant here, with a double barreled shotgun, killing him instantly, and then emptied the other barrel into himself, with fatal effect. Moore claimed that Henderson owed him \$30,000.

SUPERIOR, Wis., July 23.—The shingle mill, all the machinery and a large amount of shingles owned by J. A. Taft, was totally destroyed by fire about 11 o'clock to-night. The loss is estimated at \$1,500, insurance about \$500. This is the third destruction here near the same place within last six months. The steam barge Charlemagne Tower, Jr., arrived with railroad iron this evening and will be unloaded to-morrow. The weather is cloudy and cool, with a light southeast wind.

Eau Claire, July 23.—The council spent much time fruitlessly at the regular meeting this week in wrangling with the mayor over the trial of Officer John McClellan on charges made by the mayor, and no progress was made in the matter. The council adjourned until Aug. 1. Hon. O. H. Ingram has called the attention of the city fathers to the necessity of making early provision for improving the channel of the Chippewa river above the Madison street bridge, he being convinced that Maj. Allen, government engineer, will expend none of the Chippewa river appropriation at that point, at which the banks are in such a condition that a freshet would probably cause for it. The prohibitionists of the city have begun the publication of a weekly organ entitled "The People's Voice," which contains serious charges against city officials, among them being the accusation that the chief of police was a dead drunk with "other city officials" at the Fourth of July celebration. The charges are believed to be entirely groundless and the first issue of the new organ has made a bad impression on the public. Secretary Knudson of the Y. M. C. A. has gone to Ashland to hold a series of gospel meetings in connection with the mission there. The assets of E. J. Brunner, recently appointed, are about \$5,000 and the liabilities about \$4,000. At a meeting of workmen last night a committee of nine was appointed to consider and report on the advisability of establishing a furniture factory and a wood-cure factory on the co-operative plan.

OWATONNA, July 23.—Harvest in this vicinity has begun to ripen. The wheat has ripened very quick and there are but few fields which are not ripe enough to be cut. Judging from the reports of the farmers the average yield will not be above ten or twelve bushels per acre. A few fields will not be cut on account of their diminutive growth and the work of chinch bugs. J. W. Gillett has removed to his farm to spend harvest and staking. Dr. E. M. Morehouse has excavated a cellar and commenced laying the foundation for a four-story building adjoining his block on Broadway. Deputy Postmaster Hughes of Minneapolis, was in the city yesterday. C. J. Kingdon will arrive home next week.

CHIPPWEA FALLS, Wis., July 23.—The city engineer has plans furnished for a complete system of sewerage. All labor will be employed entirely in this city. Gov. Poindexter's new residence and driving park are nearly completed. Alfred Spence of the town of Larriere fell from a scaffolding, while at work a distance of fifteen feet, and received probably fatal injuries. Four new crews will be put on the passenger service of the Wisconsin Central on this division Monday. The lumbermen of this division are now piling lumber and boom company, has closed a contract with W. Jacobs to operate on the West Fork of the Red river, embracing 4,000 feet—a six years' job. One hundred and twenty new gas posts for street-lighting purposes have been ordered during the past week. Ex-Policeman Ambrose Brown died this week.

A CHICAGO FAILURE. Snyder & Hoole, Bookbinders and Stationers, Go to the Wall—Liabilities \$300,000.

CHICAGO, July 23.—The firm of Snyder & Hoole, bookbinders and dealers in printing materials, at No. 173 Monroe street, has failed to-day. Last evening about \$8,000 worth of the company's stock was attached by the sheriff to settle the claim of a New York creditor. This morning the sheriff executed an attachment for \$7,000, taken out by the New York Dyeing & Printing company. This made \$15,000 worth of the firm's property in the hands of the sheriff. This afternoon Mr. Hoole, the supervising partner of the firm, made an assignment in favor of Warren O. Tyler. Mr. Hoole placed the liabilities of the firm at \$300,000, with assets of an equal amount. The creditors of the firm are nearly all Eastern houses. The stock in the store at Monroe street is worth about \$50,000. The firm has another house in Olmsted. The only cause assigned for the failure is the dullness in trade.

A Man of Gesture. Washington Hater. Joseph Cannon, the loud-talking member from Illinois, cannot speak a minute without striking out vigorously with his left arm. The faster he talks the swifter his left fist flies through the air at the Democratic side of the house. His compliments are always left-handed. One day, two or three sessions back, "Sunset" Cox had the floor in the midst of an important debate. Cannon jumped up to ask him a question, and, as usual, set his left arm in motion, with the long, bony forefinger violently vibrating toward the head of the New York humorist.

"I will grant the gentleman's request upon one condition," said Cox.

"What is it?" asked Cannon.

"That you put your left hand in your pocket and keep it there until you get through with your question," replied Cox.

Cannon was not a little nonplussed at the novelty of the request, but proceeded to comply with the terms. He did not get half through with his question, however, before out flew his fist on a level with "Sunset."

A HARMLESS CRANK. The Man who Wanted to Talk With Cleveland Only Wanted a Job.

ROUNDOUT, N. Y., July 23.—Nathan Schuler, the young man arrested by the Albany police yesterday for fear that he might be a possible Gultean, is a resident of Roundout and can best be described by the Scotch phrase, "an innocent." In Roundout he has always been looked on as a harmless crank, and has served as a butt for practical jokes. When Mr. Cleveland was elected president Schuler wrote to him asking for the position of postmaster at Roundout. The Freeman has a copy of this letter, which is a literary curiosity, Schuler is a Hebrew. Every week or so he proposes marriage to young ladies. His antics are amusing, but do not frighten anybody. Two or three years ago he wrote doggerel poetry, and when he could raise money to buy stationery and stamps he sent his verses to prominent men upon the Hudson river. Occasionally he has had some merchants give him old stock to peddle on the streets. When the postal inspectors were inspecting the Roundout postoffice, two weeks ago, a stoker indeed, called on the officials and demanded that office be turned over to him. He has always spoken enthusiastically about the president, and there seems to be no doubt that he went to Albany to ask the president for a position. Schuler never realises when given a name, mercifully by small boys. He never was known to carry a weapon, and is looked upon with brotherly compassion. Schuler's letter to the president was written in the Roundout Y. M. C. A. rooms. He asked Secretary A. M. Wilcox for a sheet of paper, which was given, and two hours later handed a letter, of which the following is a verbatim copy, to Mr. Wilcox: Roundout, Nov. 2, 1885.—His highest Excellency: To the highest respects to Hon.
