LONDON, July 21.—The Nationalists are thought to have a clear case against the government in the death of John Mandeville, who was arrested and confined while in Tullamore jail no longer doubts were the cause of his demise. The story of his incarceration as told by his widow and other witnesses at the inquest is pathetic in the extreme, and if any other man were to make Mr. Balfour an object of greater execration and hatred in Ireland this painful narration is destined to do so.

INSULT TO THE PONTIFF. That is how Catholics regard the meeting of the Emperor William and King Humbert at Rome. BERLIN, July 21.—The emperor's projected meeting with King Humbert is definitely fixed for October under the instigation of Prime Minister Crispien. King Humbert has asked the emperor to visit Rome and the latter has assented. The pope being apprised of this, has sent a vicar general to Prince Bismarck declaring that the emperor's presence at Rome would be an act of hostility toward the Vatican.

STANLEY'S WHEREABOUTS. There Seems to be Little Doubt That the "White Pasha" is Livingstone's Savior. Special Cable to the Globe.
