SUPREME COURT DECISIONS.

Grist from the Mills of Justice Running Rapidly. TRADE TALK JUSTIFIABLE. Five Litigants Disposed of According to Law and the Evidence—Balloons Must Not Question Judgments.

The judges of the supreme court are turning out decisions at a rapid rate, a number being filed yesterday. Peter Stollberg, appellant, vs. A. Brandenberg, respondent, is a suit arising out of the illegitimate spelling in a mortgage deed. Judge Collins' syllabus reads as follows: "In an instrument filed as a chattel mortgage the description was as follows: 'All that certain parcel of property described as follows: north 1/4 of section 11, township one hundred and thirty-four (134), north of range thirty-eight (38), eighth (38) acres crop, 33 acres of wheat and (6) acres of all said property,' etc. Other parts of the instrument clearly indicated it to be a mortgage upon personal property. Held, that such description must be construed as covering a crop of thirty-three acres of wheat and six of oats, growing when said mortgage was executed on the land described therein in possession of the mortgagor. Held further, that said mortgage had, when duly filed, general validity. Order reversed."

In the appeal, American Steam Boiler Insurance company, respondent, vs. A. H. Wilder, appellant, Judge Dickinson rendered the following syllabus: "When soliciting defendant's insurance policy the plaintiff's agent, knowing said policy furnished by his company, was not contained in the policies issued by a certain rival company, knowing said policy was not issued by his company, however, invited defendant to examine and compare his proposed contract with that of the other company, leaving his blank form for that purpose. Defendant made application for and was insured in plaintiff's company. Held, that he could not refuse to receive the policy and avoid his obligation to pay the premiums therefor, because of said false statement."

In his opinion, Judge Dickinson says: "It seems quite probable that by means of the title called, secured an advantage, and obtained a risk to which it had no moral right. But this is not uncommon in business transactions, because rarely of perfect moral character. It is not, therefore, to be enforced. The law cannot attempt to rectify all wrongs of this character, and only interferes when craft and cunning are carried too far. In this case the agent was endeavoring to sell or dispose of an insurance in his company; was setting forth the advantages and value of its contract as compared with those of the other company. It should have been expected that he would praise and commend its good qualities, precisely as would a seller of goods. In fact, his relations were of the same kind in commercial circles as 'trade talk,' and the case is analogous to those wherein one has been induced to purchase goods having equal means of information and judgment equal as well as qualified to judge of the value as the seller. The buyer, under such circumstances, is without redress, for it is understood that the seller's statements and recommendations are to be received with great allowance and distrust."

Charles P. Holcomb, as sheriff of Washington county, respondent, vs. C. N. Nelson Lumber Company, appellant. In his appeal Judge Collins' syllabus is as follows: "When a sheriff relinquishes possession of property which has been seized and attached to him, and upon the strength of a receipt for the same, the bailee or recipient will not be permitted to question a judgment obtained in the action in which the property was so seized and attached, upon the ground that the judgment was secured by perjury and fraudulent acts and practices. Judgment affirmed."

COMETS AND ASTEROIDS.

The Year's Astronomical Progress. New York Evening Post. Prof. John R. Reed, director of the Columbia College Observatory, last evening read a very interesting paper before the New York Academy of Sciences on "Astronomical progress and phenomena for the year Oct. 1, 1887, to Oct. 1, 1888." His paper covered the whole field of astronomical research, of comets he said five had appeared during the past year. Among them was "Encke's comet," which made its twenty-fifth known reappearance. This comet is supposed to be gradually approaching the sun, into which it will finally fall.

The last comet seen this year was that discovered by Prof. E. E. Barnard, of the Lick observatory on Sept. 26. Prof. Barnard and Prof. Brooks, of Rochester, are the two most indefatigable searchers for comets now living. During the last seven years each has had several comets. They have received during this period \$2,700 in prizes. As an illustration as to how during the past fifty years searching for comets has increased, Prof. Reed stated that between the years 1837 and 1836 fourteen comets were discovered, while between 1877 and 1876 there were forty-nine of them. The professor said one of the chief things now needed by astronomers was a clock so arranged that it would keep time to the precision of the telescope. The period of an hour or more pointed at exactly the same part of the heavens, turning the telescope automatically as the earth turned on its axis. Prof. Reed also spoke of the aid that photography was now bringing to astronomy, allowing the observer to take exact pictures of stars, from which afterward could be deduced the most valuable measurements and conclusions.

In speaking of the asteroids he mentioned the discovery and rediscovery during the past year of several of these planets. He stated that the whole volume of which equals only 1-7800 part of the volume of the earth. Altogether they number hundreds of all sizes. The professor stated that one of the most recently discovered of these planets had just been named in honor of the daughter of a well known scientist. In the difference, he said, "The Leaves at least are Red."

Sanity in Christian Science. Dr. Hutchison—I am glad to note a return to sanity in the matter of Christian Science, so called. Many who gave their firm adherence at first have seen that it is a rank imposture and have withdrawn allegiance ashamed. Its rapid spread was due to that peculiarity of human nature that leads truth to bold assumption of supernatural power, and inhibits preference for the ipse dixit of a charlatan to the careful, thorough truth-telling physician. One of these quacks, at the time in London, was a "badger-puller," who sulked the great Abernethy for some personal ailment. Curious to know the secret of his success in attracting clients, the surgeon asked him if he knew why he had so many more patients than any regular physician. Drawing Abernethy to the window, he pointed to the surging crowd on the street below and asked: "That gentleman who just passed us," remarked Brown to Robinson, "I have met several times, and if he notices you at all, he looks you square in the face. I like that style of man."
