AN INJUNCTION ISSUED.

Which Temporarily Blocks the State Park Scheme.

Yesterday morning when Comptroller Calderwell reached his office in the city hall, he was the proud possessor of an injunction restraining him from countering the warrant for \$100,000 drawn by the president and secretary of the park commission to reimburse G. C. Gale and E. M. Johnson for money advanced to complete the purchase of the state park.

The injunction was issued by Judge Smith on the application of Mrs. Vinette Lincoln, and was served on Mr. Calderwell as he stepped from the train at the depot on his morning excursion to Buffalo. The injunction is temporary, and is to be heard at the special term next Saturday before Judge Smith.

Mrs. Lincoln was one of the property owners who were scooped out of their land by the state park scheme. She sought the appointment of the court, and after a long and arduous trial, the committee state in the last legislature. This is her last opportunity to prevent the consummation of the plan.

Thomas A. Sully, she means to try this last chance. The grounds on which the injunction was sought were constitutional, the claim being that the park commission had imposed a burden of taxation on the city of Minneapolis, and impaired the constitutional "equality of taxation."

She affirms that she is the special owner of the land in question, and that she is entitled to the value of \$100,000, and personal property to the amount of \$50,000, which will be unduly taxed if the city appropriates \$100,000 to pay for the state park.

The only persons who seem to have gotten into trouble by the injunction are the gentlemen who advanced the money on the purchase of the land. They did so because the city could not do it, and the park board had no power until it pushed a bill through the legislature to raise the money.

These bonds were sold, and the board last Saturday ordered a warrant drawn in favor of S. C. Gale and E. M. Johnson for \$100,000, which has since been paid, and has thus joined from countering.

THE BOILER EXPLOSION INVESTIGATION NOT OVER YET. The council committee called yesterday did not do much work beyond the allowance of claims. The fire department and salaries' committees met and agreed to recommend the old schedule for members of the fire department.
