The capital represented is about \$3,000,000. Another company has works in course of construction costing \$500,000. The rock and clay found here has been tested for two years, and is pronounced to excel any ever discovered for making cement. It shows 30 per cent greater strength than the product of the famous English mines.

IOWA CROPS LOOK WELL. The Outlook is Highly Encouraging. DES MOINES, Ia., June 28.—The Iowa weather crop bulletin for the week says: The chief features of the weather during the past week were, and are getting to be, high temperature and high percentage of relative humidity, with more than average amount of sunshine. Rainfall was not well distributed, a few localities reporting a large excess, and the bulk of the state less than normal. The damage by flood, wind, hail and lightning, resulted in sections covered by severe storms. But the great bulk of the state is not suffering from either excess or lack of moisture. The week has been generally favorable for clearing fields of weeds and for "making hay while the sun shines" and for getting up the crop in better improved. Corn is making rapid progress except in a limited area, and the present outlook for the crop is nearly as favorable as the one reported during last year. Other cereal crops are doing well, the principal complaint being of the excess of straw. In some counties and the appearance of rust in sections where the rainfall was the heaviest during the recent heated weather, the crop outlook is highly encouraging for this season. The harvest of winter wheat has begun in sections in the southern counties, and the yield is good. Barley will soon be ready for the reaper.
