INTO THE DEATH PIT.

Rescuers Effect an Entrance Into the Hill Farm Mine at Dunbar.

The Bodies of the Entombed Miners May Be Recovered To-Day.

Whisky and Petroleum Ignite in Louisville, Causing Two Conflagrations.

Lightning Strikes in Fifty Places at Columbus, Killing Two Persons.

Dunbar, Pa., June 30.—On the new course to-day the rescuing party dug through about twenty-five or thirty feet of solid coal, and at 11 o'clock struck an entry to the Hill farm mine, the rescuing party can dig away the coal, so that the search for the entombed men can progress. The utmost secrecy is maintained, and the rescuing party is kept in the dark as to the progress of the work.

Five Acres of Fire.

Forty Deaths From Sunstroke in Chicago.

Chicago, June 30.—The number of deaths from direct cases of sunstroke and causes due to the heat is largely in excess of that reported in the papers. At the office of the coroner, this morning, the scene was a busy one. The clerks were kept busy attending to death announcements, and the coroner and his deputies busied themselves preparing for the inquests for to-day. At 1 o'clock morning over 100 cases of deaths caused by the heat were made in the coroner's assignment book, and when the day was over the number had increased to 140.

Spilled a Pot of Dye.

Elmira, N. Y., June 30.—Shortly after 11 o'clock this morning a fire of Barker, Rose & Gray, the heavy jobbers and retailers of hardware in this city, spilled some Japan dye near a lantern in the basement that fell from the ceiling, and in a moment the light in the lantern had communicated with the dye, and a frightful explosion ensued. Lewis Jelson, the owner of the store, was badly burned, and Fletcher Griswold, who was with him, was quite seriously injured. Both escaped, and so were fifty other employees who were working on the floors above. The firemen were unable to check the flames, and the store was burned to the ground. East Water street, was burned, only the outside walls being left standing. The stock of Barker, Rose & Gray was insured for \$100,000, and the block, which is owned by the Arnott estate, for \$20,000. No lives were lost.

Slain by His Daughter.

A Crazy Badger Killed by His Grown-up Child.

Milwaukee, Wis., June 30.—John Goodrich, aged 56 years, was shot and fatally wounded by his daughter Lizzie, aged 26, at the family home, just outside the western limits of the city, last night. The girl says her father came home drunk and began flourishing a revolver, and that in a struggle to get possession of the weapon he was shot. The location of the wound, which is in the back, just above the hips, is not favorable to her story, and the young woman was placed under arrest. Goodrich was confined at the Knickerbocker insane asylum a few years ago, but had recovered his mental health.
