THEY FIGHT A BIT.

Sons of Veterans Show That They Have Some Scraping Blood Left. Sweeping Changes Made in the Constitution and in the Ritual. Official Programme for the Opening of the Exposition This Afternoon. C. & C. Committeemen Look at Hospital Sites--City Hall News.

Sons of Veterans like to see a great city, its lights and shadows. That perhaps accounted for their tardiness in assembling yesterday morning. Although scheduled to meet at 9 o'clock it was thirty minutes later before even a small crowd had assembled. Then Mayor Wmston was admitted. Briefly he welcomed the men to Minneapolis, listened to the acceptance of the same by Commander-in-Chief Webb, and departed, followed by a hearty cheer. The business session was begun with the report of the committee on revision of ritual. The committee reported that only a complete reorganization of the fundamental organic laws of the order would render possible the radical ritualistic changes deemed necessary. The committee had decided upon these changes as follows: First--That no ritual work should be prepared for the military rank in conjunction with the order, though some special rite may be an entirely independent organization, which would not require a separate ritual.

Second--That the order at large should remain semi-military instead of being made strictly civil. Third--That the organization of more than one degree was both unnecessary and undesirable.

There was a Rumpus. The committee then outlined the proposed changes in, and additions to, the ritual. The general instructions to candidates are to remain practically unchanged. The opening ceremony is condensed with the substitution of several post system phrases. The order of business is slightly changed and condensed. The obligation of the G. A. There were three factions. One wanted a shorter, simpler ritual; another a longer, more elaborate one; and a third wanted three degrees and a ritual for every degree. The question was left open without a vote.
