STILLWATER NEWS. An Interesting Decision in the Albrecht Case. Judge Lehmeke, of the probate court, filed a decision yesterday in the matter of the estate of Frederick Albrecht, deceased, denying plaintiff's motion to set aside an order allowing Charles Albrecht's claim of \$10,000.32 against the estate. The court finds: "That when application is made to the probate court by a person interested in the subject matter to vacate and set aside an order previously made, alleged to have been procured by fraud, misrepresentation, or through surprise or excusable inadvertence or neglect, the probate court is bound, according to the ruling of the supreme court in the matter of the estate of Mrs. Grace, deceased, Minn. Rep., Vol. 32, page 14, etc., to afford the applicant an opportunity to be heard. It is incumbent upon the applicant, however, to prove and substantiate the allegations in his petition before the probate court will set aside an order previously made and entered. In the case under consideration the court finds from the facts disclosed by the evidence that the petitioner has failed to prove and substantiate the allegations in his petition. It is therefore ordered that the order to vacate and set aside the order allowing the claim of said Charles Albrecht, as herein recited, be and the same is hereby set aside and refused."
