POISON FOR THE RICH

Chicago Detectives Claim to Be Aware of a Diabolical Conspiracy.

Chicago, April 16.—Chicago detectives confirm the reports of the existence of an anarchistic organization with headquarters at Chicago and branches in all the principal cities in the country.

The object is to introduce poison in the guise of servants into the homes of the wealthy.

The conspiracy is not new by any means, said a member of the city detective force today.

"I found out about this thing years ago, but have never been able to lay my hands upon it with sufficient force to break it up. It is worked in a very secret manner.

The most fierce and uncompromising anarchists in Chicago are not men, but women. They are the wives of

anarchists, and they are in constant correspondence with their friends and relations in Europe.

They send over for green girls and promise them good places when they arrive. The places are secured through the intelligence offices.

American—even the wealthy people do not ask their servants for recommendations. They take them on trial from the intelligence offices.

Now a young girl arrives here and is at once taken to the home of the anarchist, who get her a place on the promise that she will divulge to them all she can learn about the members of the family.
