The Mississippi, from which the supply is drawn, is the lowest ever known at this season of the year. The gauge in the channel shows the water below the zero mark, which means that at the chain of locks plant but one intake is under water, while at Bissell's point, a dam in the city engines are pumping water into the conduits. A fall of a single foot will shut off the city's supply from the river entirely. The cause is the blockage of the Missouri at Hornum, Mo., and the Mississippi at Alton, Ill., with ice. A number of them will be broken up, but must come soon to relieve the situation.

ST. LOUIS WATER FAMINE.

ST. LOUIS, Dec. 8.—The city is facing a water famine unprecedented in its surrounding circumstances. The Mississippi, from which the supply is drawn, is the lowest ever known at this season of the year. The gauge in the channel shows the water below the zero mark, which means that at the chain of locks plant but one intake is under water, while at Bissell's point, a dam in the city engines are pumping water into the conduits. A fall of a single foot will shut off the city's supply from the river entirely. The cause is the blockage of the Missouri at Hornum, Mo., and the Mississippi at Alton, Ill., with ice. A number of them will be broken up, but must come soon to relieve the situation.</
