## WON BY CORONA.

THE WHITE BEAR FAVORITE DEFEATS MINNETONKA'S MARIE

IN A VERY FINE RACE.

THE PINAFORE BEATS THE ALERTA IN A GOOD CONTEST.

WILD WIND AND MAD WAVES

Lend Great Excitement to the Regatta—Dance and Reception Last Evening.

"May God bless the man who invented time allowance," murmured the nautical Sanchez of White Bear yesterday, for, thanks to that happy contrivance, the first of the three interlake sloop races was won by the Corona. She surpassed Minnetonka's Marie by 43 seconds. The latter arrived first by 42 seconds, but, as the larger boat, she granted the Corona one minute and twenty-five seconds time allowance. Yet, impelled by courtesy and other reasons, the home club gave their Minnetonka friends a clean victory in the cat race, the little Pinafore arriving one minute and twenty-six

seconds ahead of the White Bear's Alerta, or one minute and forty-three seconds including Capt. Morse's time allowance. Thus honors are easy at the close of the first day's race, and neither club can make faces at the other.

Unlike Wednesday, yesterday supplied not only enough wind, but every variety of that essential element. The race began with a moderate ten-mile breeze, which gradually dropped off. When the race was two-thirds finished almost a perfect calm prevailed. Then came a savage squall from the southeast, the shifting wind grew stronger and stronger, and the race closed in the midst of flying white caps driven along by a twenty-mile gale.

Besides the obliging weather clerk the yachtsmen had to thank Commodore Dean and his assistants of the White Bear club for the excellent manner in which the details of the contest were carried out, affording neither side cause for the slightest complaint. Nor was there the least accident to boat or sailor throughout the trying squalls.

In considering the respective sailing qualities of the competing yachts the universal admiration must be repeated for the seamanship of the visitors, than whom there are probably

no better sailors.

The starting gun for the big boats was fired at 2:30, and from that moment both boats were obliged to count their "flying start," although, as a matter of fact, the Corona crossed the line about three seconds and a half behind the Marie. Starting first, the Minnetonka boat kept ahead, and gained a considerable advantage during the greater part of the race from the fact that a defective rope confining the Corona's jib kept constantly stretching. At the first buoy the Corona had made up a good part of her lost time, and was but 28 seconds behind the Marie. The sloops rounded the Lake Shore buoy in about the same relative position. Thereafter the defective jib attachment on Dr. Welch's boat permitted the sail to lose so much wind that, in spite of every effort made to adjust matters, the Marie had gained a lead of 1 minute and 20 seconds at the Center buoy, and at the home buoy, on the first turn—which was won by the Marie at 3:20:30—the Minnetonka sloop had secured its best advantage during the race, and was 1 minute and 47 seconds in the lead. Neither boat gained in the run back to the Center buoy. When that point was passed Dr. Welch had tightened in

the Pinafore, and she was now in better trim and could gradually make up for lost time. From here, clear across the lake, past the center buoy and away home, the champions of the fresh water world fled before the rising gale. Both had

undoubtedly pointed closer than those of the White Bear club. But for all that the Corona, by beating the Marie, vanquished the vanquisher of Herreshoff models and of elaborately contrived sail boats that have been sent to Minnetonka by the most famous builders under guarantee to win. Thus Messrs. Welch,

Merrill and Gregg will have the satisfaction—until this afternoon—at least—of feeling that their sloop has surpassed the Marie in the inland waters of the United States. On the other hand, the Pinafore, although a smaller boat than Drake's Alerta, kept generally in the lead of the latter, and finished with a clear advantage.

ALLEGED PLOT TO CROWD DOWN THE DIFFERENT GRADES OF WHEAT.

ELEVATOR MEN DOING IT.

INSPECTION AT DULUTH SAID TO BE FOR THEIR BENEFIT.

FLAT DENIAL OF THE CHARGES.

Deputy Inspector Says the Rules Are Exactly the Same as Last Year's.

DULUTH, Minn., Sept. 5.—Charges emanating from Crookston are to the effect that there is a scheme on foot among the terminal elevators to skin the farmer in the purchase of the present wheat crop, and that a combination has been formed for that purpose. The claim is made that the grade has been crowded down to an alarming extent, and that wheat which last year graded No. 2 northern is this year graded No. 2 northern at the terminals. The direct charge is made that the state inspector at Duluth has dropped three notches in his grades during the past three weeks, and that there are some who consider the inspector is in the hands of the combination. There is no state inspector here, but the deputy for the head of the lakes says that the rules governing the inspection are the same as prevailed last year.
