STATE AND COUNTY FUNDS

Also Appear to Be in Excellent Condition From the Reports of the Respective Treasurers.

City Treasurer Wagener has prepared a statement showing the receipts and disbursements of his department for the past year. In glancing over the items under the head of "receipts" it will be noted that the sum of \$1,622,112 was realized from interest on deposits. This amount exceeds by more than \$3,000 the yearly appropriations for the salaries of the city treasurer and his eleven employees. In many cities the treasurer is allowed the interest on deposits by way of fees. The city has received 2 per cent interest for its deposits. The report in full, which is subjoined, shows that the total receipts for the year 1895 were \$4,749,810.53, and the total disbursements \$4,553,963.91. This leaves a balance on hand at the close of the year 1895 of \$195,846.62, and the balance on Jan. 1, 1896, of \$377,556.25.

The receipts credited to the general fund amounted to \$355,903.37.

SOME MONEY LEFT.

County Treasurer Edmund Makes His Annual Report.

County Treasurer Edmund's statement of the receipts and disbursements of his office for the year just ended shows that the total receipts for the year were \$3,598,221.29, while the disbursements were \$3,285,779.63, leaving a balance of \$312,441.66 in the treasury. The balance a year ago being \$195,767.61. By comparison with the year before, it will be seen that taxes have been paid more promptly the year past than they were the year before. The total receipts for 1894 were \$3,238,779.63, and the disbursements \$2,835,779.63, leaving a balance of \$403,000.00 in the treasury.

With a view to making comparisons with the rate of taxation and the promptness with which payment has been made in this city, the county treasurer writes to the county treasurers in a number of counties in different states in which are situated the cities of the same name.


