FIRING THE FIELDS

CUBAN INSURGENTS ARE DESTROYING PLANTATIONS IN MANY PROVINCES.

SIX MILES IN ITS EXTENT

THE SIZE OF ONE DISTRICT GIVEN OVER TO THE CONFLAGRATION.

REUNION OF THE LEADERS HELD

Plans Agreed Upon and Left to General Maceo and Bandera for Execution.

HAVANA, March 14.—The steamer Santo Domingo, which arrived here today from Montevideo, brought 109 volunteers from that city to serve with the Spanish army against the Cubans. They are commanded by a captain in the Argentine army, Manuel Serrano. A great fire has been seen in the direction of Nueva Paz, on the borders of the provinces of Havana and Matanzas, and the commander of the district of Jaguay Chico reports that the insurgents have burned considerable property at La Piedra. Advice received here from Roberto, in the district of Jaguaramas, province of Santa Clara, says that the insurgents have burned fields and plantations from Real Campina to the colony of La



Rosita, a district six miles in extent, and close to the railroad. A dispatch from Cardenas says that at the Central plantation of Jucaro alone it is calculated that 62,000 tons of cane were destroyed. The splendid plantation of Teresa, with all its buildings, in the district of Melena, has also been burned. The insurgent leaders have celebrated their reunion at Manjuari, and it is understood to have been agreed that Maceo and Bandera will pass through the province of Havana and Pinar del Rio. They came galloping through the country and destroyed partially a bridge at Alamo, Pinar del Rio. Ardeno they were fired at from the forts. The Leon battalion, in the vicinity of Santiago de Cuba, has had a brush with the insurgents, during which two of the latter were killed and several wounded. Gomez was camped on Thursday at the plantation of Arroyo, in the district of Recto, and he went to the plantation of San Carlos yesterday, from which place he moved to the plantation of La Dolorida, with about 1,000 thousand men, afterwards going in the direction of San Jose, westward of the district of Cardenas. The insurgents have burned the village of Guira, near Batabano. Numerous bands of insurgents recently attacked Fort Palayo, garrisoned by twenty soldiers. This fort is located at Bajual, in the province of Havana. The insurgents, who were repelled, divided into small bands, uniting again for the purpose of attacking with dynamite a new fort which was being constructed at Santa Maria, near Rosario. This fortification was eventually partially destroyed. The following movement of troops has just been ordered: Gen. Arolas is to go to Batabano, where Gen. Bernal will be stationed at Regla, near Havana. On the other side of the harbor, near San Felipe, is stationed Gen. Melgizo. Gen. Alderson goes to San Jose de los Lajas, and Col. Ruiz is to be stationed at Salud. Other columns have been ordered to Guira, Alquizar, Zelia and Agua. Gen. Artimesia has been ordered to Nguanabo. Gen. Bernal, Gen. Linares and Col. Tort will follow upon Gen. Maceo, and Gen. Prats and Col. Viduna and Col. Galbis will follow upon Gen. Gomez, who is reported to be in the vicinity of Colisso.

TURNED MILES DOWN. Lamont Cannot See Why He Should Be Made a Lieutenant General. WASHINGTON, March 14.—Secretary Lamont has written a letter to Senator Hawley, chairman of the senate committee on military affairs, advising against the revival of the rank of lieutenant general in the army. The letter was called out by the sending to the secretary of the bill reviving the grade in Gen. Miles' interest and asking his opinion upon it as is customary in matters pertaining to the department. Without making any direct reference to Gen. Miles, the secretary says that he does not see any reason for such legislation at this time. He also gives it as his opinion that the passing of the bill would be opposed to the best interests of the army.

CANDIDATES FOR THE POSTMASTERSHIP WERE FOOLED INTO TOO GREAT HASTE.

CASTLE NOT TO BE LET OUT

UNTIL CHANGES IN CARRIER SERVICE ARE COMPLETE EARLY NEXT MONTH.

BOUNDARIES OF THE RESERVES.

Secretary Smith Makes Important Decisions Regarding Red Lake and White Earth.

WASHINGTON, D. C., March 14.—It is not likely that Postmaster Castle's successor will be appointed until the contemplated changes in the collection and delivery system take place. It is the intention to have the increase in force occur about April 1, as was arranged during Postmaster Castle's visit to Washington, and the postmaster general has concluded not to have Mr. Castle's successor appointed until after the improvements in the service are all completed. Officials who are in a position to know will not venture an opinion as to who will be the successful candidate. Rumor has it that ex-Postmaster William Lee will ultimately get there, and this opinion is strengthened when it is remembered that J. J. Hill came to Washington recently to intercede in behalf of Lee.

BOUNDARIES FIXED.

Secretary Smith today rendered a decision on a question submitted to him as to true boundaries of the Red Lake and White Earth reservations. In all the lines, southern, northwestern and eastern, he decides that the line should be ascertained on the ground that to disturb them now would be to overthrow vested rights, which is against public policy and a long line of precedents. He declares that the line in this case was as to what was the source of the Black river. Butler's survey of 1875 designated the source of this river as the point where running water entered it from the east. The contention was made that the source of this western branch was the true source of the river, but the secretary holds that the line established by the original survey is correct. He also holds that to break this line, this river so many years would deprive the Indians of their vested rights to about 200,000 acres of land and about 25,000,000 feet of pine lumber, which has been appraised at their expense. A number of homestead entries have been made for the lands in dispute, and the secretary directs the commissioner of the general land office to discontinue all entries in accordance with his decision. They will, of course, be rejected. The secretary says the state's swamp land claim will be disposed of at an early date.

IN THE WASTE BASKET.

That is Where Mr. Linton Deposited the Challenge Sent to Him. WASHINGTON, March 14.—Representative Linton, of Michigan, the


leader of the A. P. A. sentiment in the house, received some days ago, a letter from Capt. Thomas Phelan, of Kansas City, challenging him to fight a duel at Blacksburg. Mr. Linton paid no attention to the communication, and from some other source it found its way into the newspapers. Mr. Linton was asked today if he had made any reply to the challenge. He said: "Ever since the house defeated the appropriations for sectarian institutions in the District of Columbia bill, partly through my efforts, my mail has been loaded every day with great numbers of letters from religious fanatics and cranks, denouncing me violently, threatening dire vengeance and death in various forms. All of these letters I have thrown in the wastebasket. I may conclude to make some reply, not so much to the Phelan as to the maniacal spirit which he represents. Of course, fighting duels is not in my line. That sort of performance is considered rather ridiculous by Americans of this generation. The threats which I have received from cranks have not alarmed me in the least, and I would have preferred that no publicity be given to them. I am not an enemy to the church, but I am unalterably opposed to government appropriations to assist sectarian work, and to any sort of union of church and state, and shall continue to oppose them."

WESTERN CHURCH LEAGUE.

CHICAGO, March 14.—The church societies of St. Louis, Cleveland, Ann Arbor, Louisville, Milwaukee and Oberlin met with the Western Church League, which was organized last night and formed the Western Church League. The new association is designed to bring into harmony the church societies of the cities west of Pittsburgh.

WHI CARRY ARMS.

CAIRO, March 14.—The British Egyptian troops under orders to proceed up the Nile in the direction of Dongola will consist of 5,000 men. All will carry arms.

Delegates From the Fifth District Are for the Ohio Man. MILWAUKEE, Wis., March 14.—The Fifth district Republican convention held here today adopted resolutions endorsing the presidential candidacy of William McKinley and urging the renomination of Congressman S. S. Barney, M. H. Youmans, of Waukesha, and Theodore Zellmer, of Milwaukee, to be elected delegates to the national convention, and Daniel E. Lintley, of Ozaukee, and George W. Spratt, of Sheboygan, alternates. W. J. Jones was endorsed for chairman of the state central committee, and including tonight conventions have been held by two-thirds of the counties of the state, and in all but five delegates were instructed for McKinley. There is now no doubt that Wisconsin will send an instructed McKinley delegation to St. Louis.

Y., March 14.—Conventions to elect delegates to the Republican national convention at St. Louis were held in each of the congressional districts of Erie county today. The resolutions adopted by the Thirty-second district convention declared for Morton as a matter of state pride and because of the long and honorable career of the state's present governor, while the Thirty-third convention resolved: "That we stand for home rule; home markets; honest money; protection to home industries; and for their brilliant representative, William McKinley."
