The bodies of John Underwood Putnam, Anna Townsend Putnam and Jessie Elizabeth Newhall were taken to the understanding establishment of Johnson & Landis.

Three of the victims of the sad drowning accident were conveyed to their last resting place at Lakewood cemetery yesterday afternoon. These were Miss Bessie Newhall and her companions, John U. Putnam and Miss Anna Putnam. The funeral took place at the Newhall residence, 1509 Vine place, at 3 o'clock. This was in accordance with the wishes of the bereaved families, who felt that their loved ones who had parted this life in company should still be together when their funerals were held.

The funeral was attended by a large number of friends, and evidences of the esteem in which the young people were held was apparent in the faces of all. It was one of the saddest leave-takings of the dead in the history of the city. The services were conducted by Rev. Mitchell, rector of the Swedish church, St. Paul, where Mr. and Mrs. Newhall, parents of Miss Bessie Newhall, found spiritual consolation for many years. The pastor spoke with deep feeling, taking care to point out the great value of life and the great importance of being prepared for the last scene of all.

ALDERMEN INSPECT THE WORK ON THE NEW WATERWORKS RESERVOIR.

FINEST IN THE COUNTRY

A NOTABLE FEATURE OF MINNEAPOLIS IMPROVEMENT COSTING A QUARTER MILLION.

CLOUGH GIVEN A RECEPTION.

Bodies of Three of the Victims of the Annandale Drowning Accident Laid to Rest.

The aldermen have taken three official pilgrimages to the new reservoir plant on Columbia Heights, and upon each occasion the rain has fallen in deluges. But that does not appear to have hooded the work, for since the last visitation of the city fathers, a wonderful change has been wrought in the scene. When work ceased last fall the two north basins were in a half-excavated state, and only one of them was ready for the first treatment of concrete and cement. At the present time Basin No. 1 is already half-covered with concrete and cement, and work on the second basin is far advanced. Even the aldermen did not appreciate the magnitude of the undertaking until their inspection of yesterday, and they now feel a very pardonable pride in the work, which, when completed, will be the finest water system in the country.

Basin No. 1, at its present stage, shows plainly the thoroughness with which the work is being done. City Engineer Cappelen has profited by the experiences of other cities, and will make no mistakes. Although money is not being spared to make the work permanent, there will be a large saving over the original estimate made by the city engineer. The four pretty gate houses are about completed, and will materially add to the attractiveness of the place when the entire undertaking is finished.

At present there are about 380 men at work, most of whom are engaged on the concrete and stone work. Up to date about \$260,000 have been spent in the construction of the first two basins. City Engineer Cappelen is especially pleased at the manner in which the stone work is being done, and believes the contract, which was let to the Minneapolis and Kettle River Sand Stone company, will be faithfully carried out. There was some opposition to these contractors at the time the contract was let, for the reason that the work would be done outside of the city, but up to date there has been no trouble in securing prompt deliveries. But it is a pity that the stone is not better than the present time five carloads of stone are being laid per day, and Ald. Anderson, Jennings and Rhode, who are contractors and practical men themselves, say that the work and the material is all that could be desired. Beginning Monday, the stone work will also proceed on Basin No. 2, and the workmen will use over two carloads of cement per day.

The natural character of the soil on the site of the reservoir will add materially to the permanency of the work. It is a clay, mixed with the proper proportion of sand and gravel, forming a solid base. Two years ago the city of St. Louis constructed an immense basin on filled ground, surrounding the city. The Minneapolis basins will not be liable to the same mishaps, on account of the natural formation of the dirt.

The two basins commenced will be completed at the earliest possible moment, and each will have a capacity of 90,000,000 gallons. The daily consumption in the city is about 10,000,000 gallons. St. Louis has indorsed City Engineer Cappelen's views of a mechanical chemical filtering plant, by providing for the construction of a similar plant for that city.

Even the conservative newspapers of all shades of opinion are severe in their criticism of A. J. Balfour, the first lord of the treasury, and Conservative leader in the house of commons. This has greatly discredited his leadership and there are rumors in circulation that he may be compelled to retire from the conduct of the government's business in the lower house. The opposition newspapers do not claim the credit for defeating the bill, but insist that it is purely the result of a revolt within the Conservative party. They assert that no such revolt against parliamentary leaders has been known since the days of Peel and they hold that it furnishes clear proof that the English do not intend to allow themselves to be "Priest ridden."

The speaker says that the government has suffered moral shipwreck, and that it may remain in office two or three years, but that its prestige is gone.

The Cobdenites have today been celebrating the jubilee of the abolition of the corn laws with a dinner at Greenwich, at which the earl of Kimberley, Lord Playfair, Leonard H. Courtney and Thomas G. Shearman of New York, were among the speakers. An address was presented yesterday to the father of the house of commons, the Right Hon. Charles Pelham Villiers, member for South Wolverhampton, the only survivor of the quartette which carried the measure to success. In this address is the following curious admission: "England is an exception to the prejudices of the civilized world." This caused the Globe today to remark: "Perhaps it is not altogether wonderful that, after our failure to convert any of our rivals, the suspicion is beginning to be entertained that the civilized world may perchance be right. The suspicion at any rate exists and may develop a force with which statesmen will have to reckon. Only the most rash will now venture to prophesy that in another fifty years England will be a free trade country."

There is no doubt that a substantial amount of sentiment has grown up in England of recent years. Even the Saturday Review admits free trade has "only a handful of celebrants, while all the world over the dominant tendency is in direct opposition to the doctrine which it was fondly believed was established for all time in 1846. The speaker, while strongly upholding free trade, does not hope that other nations will charge speedily. It says: "It is possible that the commercial treaties and arrangements at present occurring in both hemispheres, including the Pan-American efforts of the United States, will eventually prove the best doors for free exchange."
