The much agitated point in the new primary law, which has been tried this summer for the first time, is the time limit, which has caused more or less speculation among politicians and others interested as to just how the law should be interpreted.

The law distinctly says that the primaries shall close promptly at 9 o'clock. The law has not been followed in a general manner. One case is reported where there was a line of nearly 200 when 9 o'clock struck, but the voting was not stopped until all of those had cast their votes.

County Attorney Peterson, on being asked about the disputed point, said: "Inasmuch as the law was made with the special intention of giving the voters a chance to cast their ballots, I should say that the voting place should be kept open until all have voted who are entitled to that privilege."
