STATE PRINTING COMMISSION

MET YESTERDAY, BUT DECIDED NOT TO OPPOSE THE MEASURE FARTHER.

FLOOD RELIEF DISTRIBUTORS

Are Named—Veto Is Probable on the Bill Abolishing the Fire Warden-ship.

Gov. Clough will sign the Sperry printing bill, the Globe is reliably informed, in spite of the pressure which has been brought to bear upon him to veto it.

In addition to the agitation among the heads of minor departments, the matter was brought to a crisis yesterday, when the state printing commission, as an official body, met to consider whether or not it should make any recommendation to the governor in the premises. Secretary of State Berg was in favor of recommending that the bill be vetoed, on the ground that it would cripple many state departments, whose usefulness depended to no small extent on the bringing of their work to the knowledge of the people, and this could only be done by the printed reports.

The governor is being delayed in the making of new laws by the preparation of the bills, which are still in the engrossing committee. The only bill signed yesterday, for this reason, was S. C. 27, appropriating \$10,000 for the relief of Red river valley flood sufferers.

It is reported that the governor will, however, veto the bill which legislated the State Fire Warden C. Andrews out of office after the same legislature had not only appropriated the money for the work, but revised the law so as to make his work more effective.
