ONE NOTE SAID TO HAVE FOUND ITS WAY TO MANKATO.

HAS NOT YET BEEN TAKEN UP.

Other Matters Which the Body Now Examining Bank Affairs Are Said to Have Considered.

It was reported last night that the grand jury spent most of its time yesterday investigating the course of a number of notes which were held by the Minnesota Savings Bank. One of these notes, it was reported, was for \$150, and had been drawn payable in ninety days. It was said that the grand jury was told that the books of the bank showed the note had been marked paid, but Clarence Saulspau, who is said to have been a witness, told the grand jury that he had seen the note in Mankato, and that it was sent there to raise money at a bank at that place. It was also said the grand jury was told that, if they found a note had been marked paid and that it had not been actually paid but sent out for the purpose of raising money, or otherwise disposed of, that the crime of marking the note "paid" was an act of forgery on the part of somebody. Two other notes were reported to have gone the same way, but they did not find their way to Mankato.

MICHAELS' BAIL MONEY.
