LOSS OF REVENUE

IMPORTS IN ANTICIPATION OF THE NEW TARIFF OFFICIALLY ESTIMATED.

THIRTY-TWO MILLIONS OUT. BUSINESS OF FOUR MONTHS ENDING WITH JUNE TAKEN INTO ACCOUNT.

WOOL SHOWS THE LARGEST TOTAL. Nearly Twenty Millions for That Staple Alone—Sugar and Tobacco Next in Order.

WASHINGTON, July 31.—The bureau of statistics, treasury department, has prepared a statement showing the estimated loss of revenue to the government on account of increased imports, during the months of March, April, May and June, 1917, in anticipation of the increased duties imposed by the new tariff act.

The aggregate loss is estimated at \$22,666,427. The following table shows the increased receipts from the articles named during the four months ended June 30, last, as compared with the same months last year:

Goods taken from bonded warehouses, \$3,739,988, total, \$36,236,030.

The statistician is of the opinion that about 10 per cent of this increase is properly due to improvement in general business conditions, leaving the estimated net loss to the government, \$32,666,427.

The comparison of the present tariff law with the Wilson act, authorized by congress, has been completed. It was made by Charles H. Evans, who has been engaged in some capacity in the preparation of all the tariff bills with which congress has dealt since 1872.

The comparison is made in rates expressed in ad valorem terms. The statement places the average duty rate under the new law at 54.66 per cent ad valorem, as against an average of 40.10 under the Wilson law, the averages being figured on the basis of values in 1896. The schedules show the following increases in percentages: Chemicals, from 28.53 to 30.67; wools and woolsens, 47.62 to 56.54; silks, from 46.96 to 54.41; earthenware and glassware, 35 to 52.47; metals, 35.11 to 42.94; sugar, 4.94 to 7.16; tobacco, 109.06 to 121.90; agricultural products, 22.44 to 38.42; spirits, etc., 61.54 to 68.83; cotton manufactures, 42.75 to 52.33.

Some of the increases expected in revenue are as follows: Chemicals, from \$5,619,239 to \$8,423,084; earthenware and glassware, from \$8,006,839 to \$12,303,145; metals, from \$13,196,416 to \$17,457,942; wools, from \$95,748 to \$2,433,533; sugar, from \$29,910,703 to \$54,207,542; agricultural products, from \$7,727,814 to \$14,587,608. These estimates are based upon the supposition that the value and volume of imports will remain the same.

PHILADELPHIA, Pa., July 31.—Gonzales de Quesada, Cuban charge d'affaires at Washington, and Gen. IMPORTANT CONFERENCE. OBJECT OF IT CAREFULLY GUARDED BY REPRESENTATIVES OF THE JUNTA.

SOLDIERS GETTING VERY BITTER. Their Treatment in Cuba Such as to Arouse Feelings of the Greatest Resentment.

PHILADELPHIA, Pa., July 31.—Gonzales de Quesada, Cuban charge d'affaires at Washington, and Gen.
