ANDERSON LAW HELD VALID

SUPREME COURT FILES A DECISION IN THE CASE

Holds that the Counties Have a Legal Right to Tax Unused Railroad Lands—That Senator Day's Vote Was All Right—Brief History of the Case, Which is Not Yet Ended.

The state supreme court has at last declared the famous Anderson bill providing for the taxation of unused railroad lands constitutional.

The court holds that the vote of Lieut. Gov. Day, which the Anderson bill was passed in 1887, was valid, and that his tenure of office as state senator did not cease when he was elected lieutenant governor.
