

ITALY THREATENS COLOMBIA

ORDERS HER FLEET TO SEIZE

CARTAGENA CUSTOM HOUSE

Forceful Collection of the Arbitration Award Made by Ex-President Cleveland in Favor of Ernesto Cerruti, Amounting to \$250,000, Is the Object—United States May Request More Time.

WASHINGTON, July 13.—The state department has been notified that the Italian government has determined to adopt force in securing the payment by the republic of Colombia of the arbitration award made by President Cleveland in favor of Ernesto Cerruti, an Italian citizen amounting to \$250,000.

A dispatch from Caracas, Venezuela, announces that the Italian squadron, under Admiral Candian, left La Guayra on Monday for Cartagena, in order to seize the custom house there.

In view of the serious possibilities involved in the case the United States government has sought to avert an international crisis.

As Italy's action is confined to the collection of the award and no territorial purposes in view of the Monroe doctrine has no application in the case, but that it is governed by the rules which applied to the British seizure of Curacao in 1862.

The Cerruti case grows out of the political agitation in Colombia in 1885. At that time Cerruti was at the head of a large company doing business in the state of Cauca, Colombia.

During the rebellious period Cerruti was imprisoned by one of the political factions, his personal property taken from him and his business interests wiped out.

He was first submitted to Spain for arbitration, but the award was not considered a victory taken from him and his business interests wiped out.

Later the Italian government and that of Colombia agreed by protocol, on Feb. 6, 1885, to submit the entire question to the president of the United States.

President Cleveland accepted the duty, and after a lengthy consideration of the subject rendered his award on March 2, 1887, two days before the expiration of his term.

After disallowing the claims for personal damages, resulting from arrest and imprisonment, President Cleveland's award for loss of individual property was, as stated, about \$250,000.

Colombia declined to pay the amount of the award, on the ground that the president's decision was lacking in finality and left several questions open to doubt.

It was finally arranged that both governments should make inquiry as to the meaning of certain features of the award.

Thus the matter had stood until now Italy has decided to abandon diplomatic negotiations and leave it with the admiral of her squadron to settle by occupying the custom house of Colombia.

The Italian ambassador was seen this evening at the state department, except for the inquiries were submitted to this government, but it led to no reopening of the case, as the authorities here evidently regarded President Cleveland's award as final.

It is expected, therefore, that unless the seizure is deterred through friendly negotiations, no way imperative, representatives of the American charge d'affaires at Rome, that Admiral Candian's squadron will take possession of the custom house within the next few hours.

ANOTHER WAR IMMINENT.

Prospective Conflict Between Chili and the Argentine Republic.

LONDON, July 13.—Possible war between Chili and Argentina is the most interesting topic just now in the most capricious of the world.

There is a feeling that if hostilities between these countries are to be precipitated it would be well that they take place while the United States is engaged with Spain, as in that case the United States would be too busy to interfere in any little game in which Europe might wish to engage at points in South American territory.

As the interests of Italy in Argentina are large, it is said that she will dilate as to how long the war shall last and the terms of its settlement.

What ever may be the result of the pending trouble, it is said that the United States will do nothing more than protest should the situation become such as to demand attention from her.

TO CHECK THE GERMANS

ADMIRAL DEWEY ADOPTS NECESSARY RESTRICTIONS

Has Placed a Pinnace Where It Can Overhaul All Launches Going or Coming—This Move Necessitated by Reports That Germans Were Landing Provisions for Spaniards

—Dewey Reports to Washington.

LONDON, July 14.—The Hong Kong correspondent of the Daily Mail says: "Gen. Aguinaldo declares that both the Spaniards and the Germans have made overtures to him, though he declines to divulge their import."

"United States Consul Wildman asserts that Admiral Dewey could compel the surrender of Manila tomorrow if he liked. He says his dispatches show that the Germans continue to interfere, their action increasing his anxiety, as it is said, they are assisting the Spaniards by landing flour and other supplies, and, moreover, that the German officers have been seen in the Spanish trenches."

"The Germans have not been careful to observe the naval courtesies required by the situation. They have given Admiral Dewey much annoyance by going against his regulations and by insisting on sending their boats around the bay after dark. At the same time the German admiral informed Admiral Dewey that he had no intention of giving offense to America, and that his movements are not to be construed as any demonstration of ill will."

Admiral Dewey is said to have replied: "Perhaps it would be better if matters were managed a little differently."

"The German ships have done and are still doing rash and impudent things, like the landing of provisions, and the Spaniards will continue their waste of ammunition in fighting the rebels and then surrender Manila without bloodshed."

Admiral Dewey on the report that the German fleet was landing large quantities of rice and flour for the Spaniards, decided to be more strict than he has been in the past, and ordered the jetties to overhaul all launches going or coming."

FATAL FIRE AT RACINE

THREE ARE DEAD AND MANY ARE INJURED

Fire Started in the Varnish Room of the Racine Malleable and Wrought Iron Company and Spread So Rapidly That One Hundred Persons in the Building Were Caught in a Trap.

RACINE, Wis., July 13.—A fire late this afternoon completely destroyed the large three-story structure of the Racine Malleable and Wrought Iron company, resulting in a pecuniary loss of \$100,000, together with three lives and serious injury to a score or more of others.

The dead as far as known are as follows: JOHN KEEFE, JAMES KENNEDSKI, JAMES J. BODY, supposed to be Adelbert Hollister.

THE INJURED. James Dunleavy, both legs broken; Chris Poulson, fractured hip internally; George Case, cut and bruised in head; John Devey, fractured leg; Fred Potts, arm broken in three places; John Sigwart, hurt internally; John McNab, badly hurt; John Gelineau, hurt in head; Chris Bolton, back broken; John James, both legs broken; George White, injured internally; Albert Miller, leg broken.

Many others who were injured were taken to their homes and the names are not obtainable.

The fire started in the varnish room and so light was the blaze in the room at first that the men did not give the alarm at once, thinking they could extinguish it. All of a sudden the flames leaped out into an adjoining room and flames enveloped the whole building, in which were imprisoned one hundred men.

Those on the ground floor had no trouble in escaping and most of the men on the second floor got out without injury.

The workmen on the third floor were practically caught in a trap. So suddenly did the flames reach them that several were blinded or suffocated by the smoke before help could reach them.

Though the fire company was but a block away, the building was a mass of flames before the department arrived.

Many of the workmen appeared in windows crying for help, while others jumped from the street below, receiving fatal or serious injuries.

Gustave Corrick, a machinist, who was working on the second floor when the fire started, said: "When we heard the alarm I started to lay the hose to try to put out the flames, but the fire seemed to burst out from everywhere in an instant, and all the men rushed for the windows and jumped out."

The firemen could do nothing except to prevent the spreading of the flames to other buildings.

There was an insurance of \$50,000 on the building. Two hundred men will be thrown out of employment. The plant will be rebuilt.

MISSING ACCOUNTED FOR.

At a late hour tonight nearly all of the missing have been accounted for and the only dead and injured known are those whose names are given above.

The fire was the worst experienced by Racine in many years. The scene was a fearful one. The screaming of relatives of the endangered workmen was pitiful.

The first man to leap from the third story was John Sigwart, who was badly hurt that he died in ten minutes.

Gustav Kennetski, a hunchback, was the second, and his neck was broken in the presence of 5,000 horrified people.

James Dunleavy leaped from the second story, and both of his legs were broken.

Chris Poulson jumped from the second floor, and one leg was broken and he sustained internal injuries.

Then George Case was seen to come headlong out of the second floor. He struck a telephone wire, and fell to the walk badly injured.

Albert Miller leaped and the crowd tried to catch him, but his leg was broken in the fall.

John Carlin, an old man, was dropped from the second floor by younger men and luckily he was not hurt.

Dozens of men and boys were seen flying through spaces on every side of the building. Some lay still after they struck the ground, and many had to be carried away. Others who jumped were bruised and were apparently unhurt.

All of this time flames were bursting from the windows and doors and the men were seen to approach the east windows, where they fell back, no doubt to their death.

SENATOR KENNEY NERVOUS.

Damaging Testimony by Defaulting Teller Boggs.

WILMINGTON, Del., July 13.—The third day in the trial of United States Senator Kenney, of Delaware, charged with aiding and abetting the self-concealing power of the First National Bank, of Dover, William N. Boggs, in defrauding that institution of over \$100,000, opened today with further testimony relating to Senator Kenney's individual account with the bank.

During the moments prior to the opening of court, Senator Kenney, pale and apparently nervous, assisted his counsel, Senator Gray and Levi C. Bird, in arranging the papers of the defense.

The morning session was taken up with testimony relating to Senator Kenney's accounts with the bank and its correspondents.

At the afternoon session of court William N. Boggs, the defaulting teller, was on the stand for over three hours, during which he told of the manner in which he carried along checks of Senator Kenney, received from other banks, and credit deposits for him when he had overdrawn his account.

and while Boggs was a defaulter in large sums of money, that he was a defaulter, witness said, was known to the senator, and when asked why he carried the defendant's checks along for weeks without charging them, he said it was because "we are all in the hole together."

During nearly all the period in which the witness' defalcations took place, he said Senator Kenney was cognizant of the fact. As to this custom in dealing with Senator Kenney's checks, he said that, if the account was not good for them, he would pay them out of the funds of the bank, carrying the check as a cash item from day to day, or withholding the deposit slip of another depositor.
