FOR PRISON SUNDAY. Secretary Jackson Urges the Clergy to Observe Oct. 23.

Secretary Jackson, of the state board of corrections and charities, directed a letter to the clergy throughout the state, urging the observance of Prison Sunday, Oct. 23, by an appropriate sermon. In it he says: In accordance with our practice in former years, we shall be glad to ensure in furnishing from this office, without charge, such literature as will enable you, without much reading, to become familiar with the recent progress and the present aspects of the question. We would suggest that you visit your county jail and that, if possible, you visit one of the Minnesota penal or reformatory institutions.

TROOPS SICK IN THE SOUTH. LIEUT. MCCORMICK REPORTS ON THE PATIENTS LEFT THERE.

Latest Advances as to the Condition of Minnesota Volunteers in the Southern Hospitals. Lieut. C. P. McCormick, of the Fourteenth Minnesota volunteers, yesterday, made a complete and detailed report to Gov. Clough of the condition of Minnesota soldiers in hospitals in the South. Lieut. McCormick was detailed by the governor early in September to check after the Minnesota sick at Chickamauga and other points where thousands had been stationed. His communication gives an individual report of each case.

There are but few of the Minnesota boys who are not rapidly convalescing, and the majority of them will be discharged before Nov. 1. Lieut. McCormick's report is as follows: I have the honor of making the following report of the condition of the Minnesota sick in the hospitals at Lexington, Ky.; Knoxville, Tenn.; and Chickamauga Park, Ga. In detail: FORTY-SEVEN AT KNOXVILLE. The first ship to enter the harbor of Santiago after its surrender of the Spanish forces and army to Gen. Serrano was a ship with sick and provisions and medicines, carrying the Red Cross to the suffering inhabitants of that island. There was no bitter or resentful mingled with our heroic our splendid and glorious humanity. There was no malice in our hearts, there was no bitterness or resentment connected with it, and when it was all over we treated our foe as generously as we could have treated him.
