RIVERS ARE RISING GREAT FLOOD IS IMMINENT IN THE OHIO VALLEY REGION

RIVERS OUT OF THEIR BEDS Rise in the Ohio is Beyond All Expectation—Waters Still Rising at a Rapidly Accelerated Rate—Rapid Advance of the Waters Endangers Property on and Along Rivers.

CINCINNATI, O., March 6.—Fifty-three feet and nine inches is the 10 o'clock stage of the Ohio river at this point tonight. This is beyond all expectations warranted by information at hand last night.

Reports from above show that the Monongahela and the Allegheny are stationary. At Brownsville and Morgantown, near the headwaters of the Monongahela, where the great supply came from to make the flood in that river, the waters are falling, with seven feet at Morgantown and twenty-three feet at Brownsville.
