ROCK ISLAND BRANCH.

THE SYSTEM TO BE EXTENDED INTO MINNESOTA AND THE DAKOTAS.

DES MOINES, Ia., July 10.—Articles of incorporation were filed today by the Rock Island and Northwestern Railway company. This is a branch of the Rock Island which is to extend the system into the northwestern part of the state and into the Dakotas and Minnesota. The capital stock is \$5,000,000 and the incorporators are at Rock Island officials. The road will run from the Gwelo Junction to some point in the northwestern boundary of the state. The work of construction will begin at once.
