

TO TALK OF TRUSTS

SUCCESS OF THE CONFERENCE CALLED BY CHICAGO CIVIC FEDERATION ASSURED

ALL SIDES TO BE HEARD

Officials of States and Labor Organizations, Members of Congress and Representatives of Tariff and Free Trade Organizations Will Be Present—Consuls in Europe Asked to Send Labor Data.

CHICAGO, July 30.—Ralph H. Eastery, secretary of the Civic Federation of Chicago, returned today from the East, where he has spent two weeks furthering the coming conference on combinations and trusts to be held in this city Sept. 13-16.

In behalf of the committee of arrangements he extended an invitation to the interstate commerce commission, and the United States industrial commission, to each attend in a body.

Thirty-five governors are appointing seven delegates each. In twenty instances the governors, attorneys general and labor commissioners will accompany the delegates.

The labor organizations' representatives include Samuel Gompers, president of the American Federation of Labor; George W. Hayes, general secretary of the Knights of Labor; P. J. McGuire, secretary and treasurer of the Brotherhood of Carpenters and Joiners; James O'Connell, president of the International Machinists; Samuel B. Donnelly, president of the International Typographical union; P. J. Morrissey, grand master of the Brotherhood of Railway Trainmen; and H. J. White, general secretary United Garment Workers of America.

An effort is being made to secure the attendance at the conference of E. J. Smith, of Birmingham, England, whose success in promoting combination movements in England is dealt with in recent advance sheets of a consular report. It is claimed that Mr. Smith's plan has been successfully worked for several years, and that it secures a sure profit to the manufacturers and satisfactory wages and conditions to the artisans without unduly raising the price of the commodity to the consumers.
