BULLET IN HIS BRAIN

FRANK MILLMAN'S DEATH MURDER AND NOT ACCIDENT, AS FIRST BELIEVED

SHOT BY UNKNOWN TRAMP

This the Most Probable Theory. Though There is Very Little Direct Evidence Upon Which to Base It—Facts in the Case Preclude the Idea of Suicide—News of the Mill City.

Frank Millman was murdered instead of being accidentally killed by falling from a Great Northern train near Wayzata, as was supposed Tuesday afternoon when his body was found on the embankment under the wagon bridge, about a block from the Great Northern's Wayzata depot.

That he was murdered was proved yesterday at the post mortem examination made by the coroner's physicians. A bullet hole was found in the head. The ball had entered immediately back of the left ear, fracturing the skull, and the bullet was extracted and upon examination proved to be of a thirty-eight-calibre. There was no powder burn in the hair or flesh, showing that Millman could not have shot himself. On the contrary, the coroner's physicians feel positive that the bullet was fired from a distance of twelve feet. The examination also showed that Millman was standing up when the bullet struck him, and that death must have been instantaneous.

Immediately upon discovering that murder had been committed, the coroner's office notified Superintendent of Police Doyle and detectives were put at work investigating the matter. The circumstances surrounding the tragedy, however, make the task of bringing the murderer to justice apparently an almost hopeless one.

When Millman left here Friday his mother asked him if he had any money. He said he had, but offered no information as to how much and his mother offered him some. He took a \$5 bill and refused to take any more. He told the family that he would probably walk out to Wayzata and might stay there a day or two. He was accompanied with some trunk man and said he could get a free ride through to the harvest field.

As nearly as the police are able to learn Millman did arrive at Wayzata Friday. Although crippled by his wounds, he walked. He was seen about Wayzata. 

STRIKER IS ARRESTED

MAN WHO SOUGHT TO PURCHASE DYNAMITE IN TROUBLE IN CLEVELAND

HE DENIES CRIMINAL INTENT

Police Will Not Say What They Think of the Case—Will Hold the Prisoner for Rigid Examination—Lawyers Contend That Boycotters Can Be Proceeded Against Under the Laws of Ohio.

CLEVELAND, O., Aug. 2.—The police believe they have made an arrest which will lead to important developments in connection with the several attempts to blow up Big Consolidated cars since the beginning of the present strike. This forenoon John Schoenthal, a striking conductor, was taken into custody on a charge of being a suspicious person, and has since been detained at the central station, where he was subjected to a rigid examination by the detectives.

Several days ago a well digger named Stokes, living at Nottingham, a suburb, told the police that a street railway man had tried to purchase dynamite from him. The report was investigated and the arrest of Schoenthal followed. The prisoner admits that he is the man who approached Stokes, but he says he made the inquiry at the request of another man, whose name he does not know. He says he was approached by the stranger, who asked him if he knew where ten pounds of dynamite could be purchased. The prisoner told the stranger that he knew a man at Nottingham who used dynamite and he might have some to sell. Thereupon he went to Nottingham, saw Stokes, but failed to get the explosive. He reported his failure to the stranger and that was the end of the matter.

The police will not say what they think of the story, but declare they are not yet through with the investigation, and they look on the arrest as an important one. Good lawyers say the boycotters may be proceeded against under the Ohio anti-trust law, which covers conspiracies of all kinds in restraint of trade. One lawyer who has examined the law, says that merchants who refuse to sell goods to boycotted persons, as well as those who assist in placing the boycott on them or aiding or abetting it in any way, can be convicted of conspiracy, the proof of existence of a conspiracy. The penalty provided is a fine of from \$50 to \$5,000 and imprisonment of from six months to a year, and each day that the conspiracy continues constitutes a separate offense.

RATES ARE DEMORALIZED.

The Chicago-St. Paul Roads Said to Be Responsible.

CHICAGO, Aug. 2.—Eastern passenger rates are in a bad condition. The Chicago-St. Paul roads are held responsible for the trouble. Most of the eastern men accuse the Western roads with providing ticket brokers in the East with the return portions of excursion tickets, the sale of which they claim not to be able to keep pace with. The Central Passenger association roads are worrying over the condition of affairs, and it is said that they will endeavor to arrange matters so that the roads that are charged with being responsible for the demoralized state will be made to stand a part, if not all, of losses sustained by the Eastern roads.

DECISION DEFERRED.

Conclusion of Trial of Spanish Officers by Court-Martial.

MADRID, Aug. 2.—At today's sitting of the court-martial before which Gen. Torres and Pareja are being tried on charges of having surrendered to the Americans before exhausting all means of defense at their command, Gen. Pareja's counsel read telegrams exchanged with the command-in-chief, showing that Gen. Torres was capitulated only on orders from a superior officer, and the town was without either provisions or means of defense. The other officers offered a similar defense.
