OFFICIAL STATEMENT FROM THE WHITE HOUSE SAYS PARTY IS NOT MADE UP

IS COMING TO ST. PAUL, SURE

"Unless something unforeseen prevents, We Will Reach Here Thursday Morning, Oct. 12, Is the Way Secretary Cortelyou, for the President, Puts the Situation—Milwaukee Will Bring the Special.

Official notice of President McKinley's intention to visit the Twin Cities was received yesterday for the first time from George B. Cortelyou, private secretary, and his notification is the significant statement that the personnel of the executive party is not yet fully determined upon, which may or may not mean that Admiral Dewey will be in the party.

The official notice to the executive committee is as follows: "Executive Mansion, Washington, D. C., Sept. 29, 1899.—Telegram received. Unless something unforeseen prevents, the president expects to reach Minneapolis 9:30, Oct. 12, and leave St. Paul at 11:30 that evening. Shall rely on joint committees to reach Minneapolis at the time as will entirely meet the wishes of the citizens of the two cities and vicinity. Several of the cabinet will accompany the president. Impossible to give complete personnel now. Will advise you later in the details of the way."
