HANGING IN MONTANA

W. C. BROOKS, AFTER A STUBBORN LEGAL FIGHT, PAYS THE DEATH PENALTY.

HAS SIMULATED INSANITY

Shot His Wife Last November, and Had Tried Ever Since to Escape the Noose—He Met Death Calmly, and It Came to Him Without Pain or Agony—Story of the Crime.

BILLINGS, Mont., Nov. 24.—William C. Brooks, the negro who murdered his wife last November, was hanged in the county jail yard this morning. The drop came at 7:05. His neck was broken by the fall, and he was pronounced dead twelve minutes later. He met death calmly, and it came to him painlessly. He walked to the gallows unassisted, and sang all the way. Just before the noose was adjusted he knelt down and offered a silent prayer. The execution was witnessed by about 300.

The crime for which William C. Brooks was put to death was the murder of his wife, Jennie C., at their home, in this city, Nov. 18, 1898. Brooks had separated from his wife, and in the afternoon of the murder, at about 5:30 o'clock, went to his wife's house and commenced to accuse her of infidelity. She denied being untrue, but this did not satisfy her spouse, and he drew a revolver and shot at her. She fled from the house, and claiming: "I am shot," Brooks followed, and after she had fallen to the ground in the street, stooped over her and shot her again. He was almost immediately arrested, the officers having been attracted by the noise of the shooting. He was arraigned the next day, but waived a preliminary hearing, and was bound over to the district court.

At the time Brooks was convicted, despite the fact that his counsel set up a plea of temporary insanity. He was then sentenced to be hanged on March 17 last, but his counsel secured a stay of execution, pending a motion for a new trial, which, on being overruled, was taken to the supreme court. The court, in August, refused to grant a new trial. From that time his counsel apprised him of the supreme court's action, Brooks has simulated insanity. All day long and the greater part of the night he sang, prayed and exhort, and so annoying became his actions that Sheriff Hubbard had to resort to gagging his prisoner. At the time of the trial, Brooks' counsel moved the court to call a jury to inquire into his client's insanity. Judge Loud had anticipated this, and had appointed three physicians of the city to examine him. This had been done and the judge read their affidavits to the effect that Brooks was simulating insanity. He refused to grant the attorney's motion, and sentenced Brooks to hang on Nov. 24. The defendant's attorney then appealed to Gov. Smith to commute his sentence to life imprisonment, but the chief executive of the state refused to do so.

RETURN WITH MONEY.

Fergus Falls and Pelican Rapids Men Back From Cape Nome.

FERGUS FALLS, Minn., Nov. 24.—D. M. Taylor returned from Cape Nome yesterday with him substantial evidences of the wealth of that now famous region. Mr. Taylor went to Alaska about two years ago, and was fortunate in being within a short distance of the gold veins of the Klondike. He first attracted attention. He secured an interest in a number of valuable claims, in company with six companions, and worked them successfully during the summer months, refusing an offer of \$40,000 for four of the best of them. About six weeks ago it was discovered that the mine were rich in dust at the depth of only a few feet. His claims were quickly abandoned for this more promising field. The government refuses to give title to lands within a certain distance of the water line, and the beach is common property. Mr. Taylor believes that at the time the winter set in, which was only a few weeks ago, the gold men were at work along the seashore, and that they were making an average of several hundred dollars daily. Each shoveled out his pile of pay dirt during the day and washed out the gold dust in the evening. Will Harris, of Pelican Rapids, who went north via the Edmonton route and has spent the past few months in this country recuperating after his terrible journey, accompanied Mr. Taylor home.



BEREFT OF REASON.


Two Insane Women Are Sent to the Insane Asylum.
