A novel suit was begun in the civil branch of the municipal court yesterday by Edward W. Villet against the barber college in this city of which D. Moler is the proprietor.

The complaint first refers to the fact that the Moler system is organized under the laws of Illinois, and it is alleged that it falsely pretends to treat and instruct pupils in hair cutting, shaving and the care and treatment of tools.

It is alleged that in July last he was induced to enter the barber college and that he was to receive ten weeks' instruction for \$50, upon the representation that the graduates would be furnished with positions worth at least \$50 per month.

The complaint asserts that the so-called instruction consisted of about five minutes in the morning, when the student is taught the art of honing a razor and the mysteries of shaving, after which he is left to himself.

SEQUEL TO AN ELOPEMENT

Miller eloped with Schmidt's wife and was arrested on his return to Eden Valley. He was placed in jail, and the second day was found dead in the jail, hanging by a rope. The coroner's verdict was suicide.



