Mining Men in Town.

SEINE RIVER GOLD DISTRICT IS SLOWLY FORGING TO THE FRONT.

FORMED A CHAMBER OF MINES. Three Dollars a Day Offered for Practical Men Who Understand the Business of Mining.

T. H. Gilmour, of Rat Portage, who is now in the city, was seen by the Globe yesterday in reference to mining matters in Western Ontario. He states that a chamber of mines for Central Canada has just been formed, as a result of negotiations in that direction which have been under way for the last four months.

Among the committee of management are the Hon. George A. Cox, president of the Canadian Bankers' Association; J. B. Monk, manager of the Bank of Ottawa, at Winnipeg; C. A. Kennedy, manager of the Bank of Nova Scotia; Oster, Hammond & Nanten, financial agents of Toronto and Winnipeg; R. H. Agur, manager of the Massey-Harris Manufacturing company; H. H. Beck, managing director of the Manitoba Assurance company; Al- loway & Champion, private bankers, Winnipeg; M. J. Alton, commissioner of the Hudson's Bay company; Robert Rodgers, manager of the Bullion Gold Mining company; D. C. Cameron, manager of the Rat Portage Lumber company; John A. McNeil, W. Kennedy, timber merchants; R. A. Mather, manager Kewatin Lumber company; T. H. Gilmour, G. C. of Rat Portage; W. A. Weir and P. R. Godwin, manager of the Bank of Ottawa, at Rat Portage; P. W. Drewry, of Drewry's brewery, Winnipeg, and a large number of other financial men and bankers.

This organization is based on the same lines as the chamber of mines of the South African republic, which has had a greater influence than anything else in inducing the great flow of capital from all over the world to the mining industry in Transvaal. The purpose of this chamber of mines is to advance and protect the mining interests of Western Canada by the collection and dissemination of information of absolutely correct statistics and information, so that any statements made which are sanctioned by it will be accepted as reliable, and on the same basis of information will give the boards of trade and chambers of commerce.

Mr. Gilmour adds that there is more actual work now in progress in Western Ontario than ever before, and while the actual bullion product for the year 1899 was double that of the year 1898, it is a conservative estimate to expect that the bullion production for the current year will exceed \$1,000,000.

Stamp mills are now in course of construction, and others which have been decided upon will be in operation before next autumn.

Mr. A. B. Whiteley, C. E. and M. E., of Mine Center, is at the Ryar, on his return from Winnipeg, where he has been reporting the progress of several mining properties which are being operated by the Rainy River Development company with English capital under his charge.

The Seine River gold district is slowly but surely coming to the front. I could mention fifty properties that are showing up extra well, and there are a few that will be eventually in any gold country. Amongst the most prominent at present are the Randolph, Golden Star, Olive, E. Roy and Golden Crescent. Speaking of the Randolph, it is simply a wonder; the best assays I have seen are 100,000, and the property with a vein 7 feet wide at the depth of 170 feet, I took from the Randolph about two weeks ago, and the vein is 180 feet wide on the north side and 280 feet wide on the south side of the vein.

The Golden Star shaft is now at the depth of 500 feet, and over 3,000 feet of drifting and cross-cutting have been sufficient to keep the present stamp mill running for a long time. I have seen the shaft, and intend to increase the stamping capacity as soon as navigation opens.

The Olive vein is only a short distance from the Golden Star and Randolph, started two years ago with only two small shafts, but has since been enlarged to believe that the present administration was the quietest only, and then sent home to their parents. 


