

Supreme court demonstrated its faith in several decisions yesterday.

They figure prominently in one of the cases involving prominent men in Cottonwood county.

The supreme court found time yesterday in addition to its other troubles to hand down five decisions each of which affirmed the order of the lower court.

The railroad commission granted the petition of the Cottonwood road and allowed them by formal order to increase the capital stock of the corporation from \$50,000 to \$70,000.

With the projected line of 70 miles the incorporators found that the original capital stock was insufficient.
